

# DEO Doda seeks better upkeep of roads, NH for smooth conduct of elections

Whereas, the J&K Services Selection Board, vide letter No. SSB/Secy/Sel/Class-IV/2021/6273-78 dated 18.10.2022, forwarded the Final Selection List/Allocation of Cadres to the General Administration Department for 3422 Class-IV posts, under the provisions of the Jammu & Kashmir Appointment to Class-IV (Special Recruitment) Rules, 2020, advertised vide Notification No. 01 of 2020 dated 26.06.2020; and

Whereas, in the aforesaid Selection List, among others, the recommendation of various candidates, selected under ESM (Ex- Servicemen) category, was kept withheld subject to clarification; and

Whereas, despite the lapse of considerable time and Notices, these candidates failed to submit any documentary proof in support of their candidature; and

Whereas, some of these candidates approached the Hon'ble CAT, Srinagar Bench in OA/CP titled Manzoor Ahmad Shah V/s UT of J&K and Ors., which has been disposed of with the following directions:

"4. Vide order dated 05-04-2023 an interim order was passed wherein the respondents were directed to consider the claims of the applicants in the same manner as their counterparts have already been allowed to join by or before the next date of hearing.  
 5. Non-compliance of the Order dated 05-04-2023 compelled the petitioners to file the contempt petition which is No. C.P./150/2023...  
 The matter is disposed of by providing that the respondents will accord consideration to the case of the petitioners particularly in view of the averments made in Para 9 and Para 10 of the statement of facts.  
 It is expected that the respondents will accord consideration in favour of the petitioners within a period of eight weeks from the date the order is served upon the respondents in accordance with the rule."

Whereas, these withheld cases of the ESM candidates were examined as per the documents submitted by them at the time of the Document Verification and, placed before the Board. The Board, in its 260<sup>th</sup> meeting, decided that these candidates shall be given a Notice to explain their position before taking a final decision on their withheld candidature in these Class-IV posts advertised vide Notification No. 01 of 2020 dated 26.06.2020; and

Whereas, the J&K SSB vide letter dated 04.06.2024, afforded a last opportunity by way of a Final Notice to these 33 ESM candidates to furnish the requisite documents/affidavit in original regarding their maximum qualification, possessed by them on academic or honorary basis. Out of the 33 ESM candidates, 17 candidates have submitted their documents before the Board, which are under examination; and

Whereas, the case of remaining 16 candidates was again placed before the Board, which in its 278<sup>th</sup> meeting, decided as under:  
 "The Board, taking into consideration that no response has been received from the 16 candidates as figuring in Table-B, despite several Notices and sufficient time being provided to them, decided to cancel their withheld recommendations..."

Now, therefore, and in view of the above, the withheld recommendations of 16 (sixteen) candidates as figuring Annexure A to this Notification for the post of Class-IV belonging to ESM Category, advertised vide Notification No. 01 of 2020 dated 26.06.2020, are hereby cancelled.
