## HC grants pre-arrest bail to Wing Commander, restrain police from presenting Challan

JAMMU: Justice Rainesh Oswal of the Jammu & Kashmir and Ladakh High Court on Saturday addressed a significant case involving a Wing Commander, P. K. Sehrawat, who had been accused of rape by a junior officer. The case was registered under FIR No. 0370/2024. dated September 8, 2024, with the Budgam Police under Section 376(2) IPC.

In his ruling, Justice Oswal granted pre-arrest

Sehrawat, acknowledging the potential impact of arrest on his professional reputation and career. The court observed that a prima facie case for bail was made, considering the petitioner's high-ranking position in the Air Force and the potential jeopardy to his service career if arrested.

While the investigation into the case should proceed, the court instructed that the charge sheet should not be filed until further notice. This ensures that the investigation remains thorough while safeguarding the petitioner from immediate legal repercussions. The court highlighted that Investigating Officer must consider the findings of an Internal Committee (IC) established to review earlier sexual harassment complaints against Sehrawat. The IC had previously concluded that the allegations

were inconclusive and not

petitioner argued should influence the ongoing police investigation.

If Sehrawat is arrested, he is to be released on bail with specific conditions. These include furnishing two solvent sureties of Rs. 50,000 each and a personal bond of the same amount. He is also prohibited from leaving the Union Territory of Jammu and Kashmir without his Commanding Officer's permission and must refrain from contacting any prosecution witnesses

The court issued notices to both the respondents and the police. Alla ud Din Ganie, the learned AAG, waived the notice on behalf of the respondents and was directed to file a status report by the next hearing. The SHO of the concerned police station was tasked with ensuring that notice to the complainant is duly served and returned to the court.

## **HC** dismisses Arbitration petition filed by M/S RK Verma

#### **STATE TIMES NEWS** JAMMU: Chief Justice (Acting) Tashi

Rabstan of the Jammu & Kashmir and Ladakh High Court on Saturday dismissed an Arbitration Petition filed by M/s R. K. Verma against Sterlite Technologies Ltd. and M/s Ericsson India Pvt. Ltd.

The petition sought the appointment of an arbitrator for resolving disputes arising from two Letters of Intent dated January 28, 2016, and a settlement from a meeting held on May 19, 2017. Sterlite Technologies Ltd. had contracted the installation of 9500 Kms of Optical Fiber Cables (OFC) and subsequently appointed Ericsson India Pvt. Ltd. as the service provider through a Fiber Roll Out and Managed Services Agreement dated March 28. 2015. Ericsson India Pvt. Ltd. then subcontracted M/s R. K. Verma for part of this work. M/s R. K. Verma claimed it completed the

work but received only Rs. 58,31,475 from Ericsson India Pvt. Ltd., with a balance of Rs. 2,04,83,525 still outstanding. Despite attempts to invoke the arbitration clause in the Letters of Intent and sending legal notices, the respondents did not comply. Consequently, M/s R. K. Verma filed a petition under Section 11 of the Arbitration & Conciliation Act, seeking the appointment of an arbitrator. Ericsson India Pvt. Ltd. argued that no amount was due to M/s R. K. Verma and that a settlement had been reached, supported by undertakings from the petitioner confirming no further

Sterlite Technologies Ltd. contended it was not a party to the arbitration agreements and had no contractual relationship with M/s R. K. Verma. The work under the Letters of Intent dated May 20, 2017, was not executed due to M/s R. K. Verma's failure to provide a Performance Bank Guarantee. The court found that the two Letters of Intent, which included the arbitration clause, were between M/s R. K. Verma and Ericsson India Pvt. Ltd.. with Sterlite Technologies Ltd. not being a signatory. Thus, Sterlite Technologies Ltd. was not bound by the arbitration clause contained in those documents.

The court also noted inconsistencies in M/s R. K. Verma's claims. It was found that the petitioner admitted in the arbitration petition that Sterlite Technologies Ltd. was not a party to the Letters of Intent containing the arbitra tion clause. Moreover, the petitioner had acknowledged in undertakings that it had no pending claims against Ericsson India Pvt. Ltd. for the work done.

Given these points, the court determined there were no outstanding disputes requiring arbitration, as the petitioner's claims were contradicted by its own undertakings and admissions. Therefore, the petition for the appointment of an arbitrator was dismissed, concluding that no further arbitration was warranted.
