Whereas, the Jammu & Kashmir Public Service Commission had vide letter PSC/DR-HE/AP-Hindi/2023 dated 26-03-2024 recommended the name of 14 candidates under different categories for their appointment as Assistant Professors, Hindi, in the Higher Education Department wherein name of Ms. Koshika sharma was also figuring in the list at Serial No. 01 under OM Category; and

Whereas, vide this Department's Notice dated 10-05-2024, all the selected candidates were advised to furnish their Bio-data including Email ID and Contact Numbers for conducting the necessary CID verification about their Character and Antecedents; and

Whereas, all the applicants including Ms. Koshika Sharma had submitted the requisite details to this Department which were uploaded on the Verification Portal; and

Whereas, after receiving the CID verification report, the Higher Education Department, in continuation to the Government Order No.349-JK(HE) of 2024 dated 27.06.2024 issued appointment order in respect of Ms. Koshika Sharma D/o Om Parkash Sharma R/o H. No. 65 Chhann Arorian Marheen, among others, vide Government Order No. 376- JK (HE) of 2024 dated 16-07-2024; and

Whereas, subsequently the Nodal Principal, Jammu vide his office letter dated 27-08-2024 has intimated that Ms. Koshika Sharma, Assistant Professor, Hindi, has not submitted her joining in the Government College for Women, Gandhi Nagar, Jammu till date; and

Whereas, vide Notice dated 06-09-2024, Ms. Koshika Sharma was given last and final opportunity to submit her joining in the office of Nodal Principal, Jammu within a period of seven (7) days indicating the reasons for not joining within the stipulated period earlier, failing which it shall be presumed that she is not interested to join on the said post in this Department and her appointment shall be cancelled without any further notice; and

Whereas, Ms. Koshika Sharma has responded to the Final Notice issued by the Department and submitted that she has been selected as Assistant Professor in the University of Jammu which she has joined in the Department of Hindi, and she would not be able to join as Assistant Professor, Hindi, in the Higher Education Department.

Now therefore, consequent upon the above, it is hereby ordered that the appointment of Ms. Koshika Sharma D/o Om Parkash Sharma R/o H. No. 65 Chhann Arorian Marheen, made as Assistant Professor, Hindi, under the OM Category, in the Higher Education Department vide Government Order No. 376-JK(HE) of 2024 dated 16.07.2024, so far as the same pertains to her (Serial No. 01 under OM Category), shall and shall be deemed to have been cancelled abinitio.

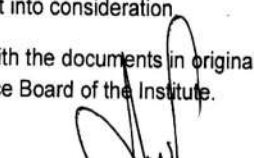

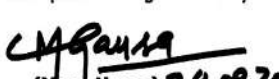
