the only option for good governance, peace, stability, and development in the region.

Highlighting Pakistan's economic struggles, Adityanath remarked, "Pakistan's situation is such that it is going around with a begging bowl. It's no secret that their government has taken their people. Even Balochistan is now saying they don't want to stay with Pakistan because they are treated like foreigners."

The chief minister also reiterated Prime Minister Narendra Modi's "firm" stance against terrorism, saying "water and terrorism cannot flow together," referring to the Indus River treaty He warned that anyone attempting to spread terrorism in India with Pakistan's support vould meet a grim fate.

"If anyone, with Pakistan's support, tries to sow seeds of terrorism in India, they will neither have a shroud to cover them nor two yards of land to be buried in."

Taking a dig at the opposition parties, including the National Conference, Adityanath said their leaders used to behave like "rulers" of Jammu and Kashmir and enjoyed foreign trips at government expense but that is not the case anymore.

Addressing a public rally in Ramnagar area of Udhampur district, Yogi Adityanath issued a stern warning to Pakistan-backed terrorists, asserting that any attempt to incite violence in the country would lead to their elimination.

"I want to say that if Pakistan-backed terrorists try to incite terrorism anywhere, they will face their worst elimination.. This is a new India, which will not tolerate terrorism but will erush it and bury it," he said.

"Today, India has a zero tolerance policy toward terrorism. If anyone, with Pakistan's support, tries to spread the seeds of terrorism in J&K, they will neither have a shroud to cover them nor two vards of land to be buried in.

The Chief Minister also cited the construction of the Ram Mandir in Ayodhya as a success of the "double-engine government" model.

"If you want to see an example of a 'double-engine government', the biggest one is the Ram Mandir in Uttar Pradesh, which was built after 500 years. When we started the process of the Ram Mandir, some people said that if the Ram Mandir decision was made and construction started, rivers of blood would flow. We said this is a new India, where security is the highest

Adityanath claimed there has not been a single instance of riot in UP in the last 7 and half year and added, "I believe Jammu and Kashmir should also be a part of such development ander the double-engine government.'

He also accused the Congress, National Conference, and the PDP of exploiting Jammu and Kashmir for political gain by "promoting terrorism."

"Who are the people who gave a religious colour to Jammu and Kashmir and turned it into warehouse of terrorism? They exploited the people, promoted family rule, encouraged corruption, and supported terrorism for their political gains," he said.

"With the scrapping of Article 370 by Prime Minister Modi, the nursery of terrorism has been permanently closed," said Adityanath, who addressed four rallies in the Jammu region in the final phase of elections on October 1. The chief minister claimed that the abrogation of Article 37 in Jammu and Kashmir has

prought peace and prosperity to the region earlier racked with violence and criticised the opposition parties of advising against the law's scrapping. "These are the same people who said, before Article 370 was abrogated, that if anyone

ouched it, rivers of blood would flow in Jammu and Kashmir. "After the removal of Article 370, the opposite happened. Peace came to Jammu and

Kashmir, development and progress took place, and people are happy, making it one of the best

"The old days of corruption, terrorism, separatism, and dynasty rule will not return. The peoble have decided to bid farewell to these three families, and after the elections, their exit will oe confirmed," he added.

"The polling in the first two phases has shown that the people of Jammu and Kashmir want beace, stability and development. This is how we are viewing this election," he said.

Lauding the youngsters of the Union Territory for their will to join the national mainstream, Nadda said, "They have given up arms and chosen the path of peace. People have also voted n favour of development.

He said the youngsters of Kashmir have rejected terrorism.

"They have joined the national mainstream. Before the abrogation of Article 370 (of the Constitution), more than 300-400 youngsters would join terror ranks (every year) and would be declared terrorists. Today, there are just four. So based on data, I can confidently say that they have rejected terrorism and violence," the BJP leader said.

Hitting out at the National Conference (NC), People's Democratic Party (PDP) and Congress for "trying to revive the era of violence and bloodshed" in Jammu and Kashmir, he accused these parties of supporting anti-India elements.

"They are supporting those activists who are working against the country. It has been mentioned in the NC's manifesto that it will release terrorists (from jails), resume cross-border trade and talks with Pakistan. This is how the NC is supporting anti-India forces and the Congress is supporting it," Nadda said.

Slamming the NC-Congress alliance for the Jammu and Kashmir polls, he alleged that the two parties have struck a political deal.

Referring to the visit of the heads of missions from different countries to oversee the Assembly polls, Nadda said, "Heads of missions from 16 countries visited Kashmir to observe the election. They saw the control over law and order and how people have increasingly participated in the polls. The election was held in a peaceful manner."

"It is a historic occasion. People have rejected bullets and chosen ballots. They have given a pefitting reply to terrorism. They have voted for peace, development and progress," he added. The BJP chief said the people of Jammu and Kashmir have reposed their faith in Prime Minister Narendra Modi and his policies in the first two phases of the polling.

SRINAGAR: At least three record seventh term in the House.

These are the first assembly elections being held since 2014 and the first after the 2019 reorganisation of the erstwhile state.

Conference National leader and former finance minister Abdul Rahim Rather is seeking a seventh term from Budgam district's Chrar-i-Sharief constituency, which he represented from 1977 to 2014.

Rather's only electoral defeat came in the 2014 elections, when he lost to People's Democratic Party (PDP) leader Ghulam Nabi Lone Hanjura. The 80-year-old veteran is

up against Hanjura once again as he tries to become the first Jammu and Kashmir politician to win seven assembly elections. Rather's party colleague

and former minister Ali Mohammad Sagar, who is also seeking a seventh term, has never lost an assembly The 66-vear-old Srinagar

strongman won his first assembly election as a 25vear-old fromBatamaloo seat, retaining it in the 1987 polls. Sagar shifted to the

Khanyar seat in 1996 and

has been an MLA for four consecutive terms.

Hakim Mohammad Yaseen has also won six assembly Khansahib segment of Budgam district, the first of which came in 1977.

The only exception was in 1996 when he did not contest the polls.

Chrar-i-Sharief, Khanyar and Khansahib constituencies went to the polls in the second phase on Wednesday.

There are several other candidates who are seeking sixth, fifth or fourth terms in the assembly.

Prominent among them is National Conference leader and former Mubarak Gul, who is seeking a sixth term as an MLA from the Eidgah constituencv in Srinagar that went to the polls on Wednesday. CPI(M)

Mohammad Yousuf Tarigami is seeking a fifth straight term from the Kulgam seat in south Kashmir while the PDP's Abdul Rehman Veeri -- who has represented Bijbehara four times -- is seeking election from the Shangus Anantnag East constituen-

Both these constituencies went to the polls in the first phase. The last phase of the assembly elections will be held on October 1. The results of the elections will be declared on October 8.

Omar asks BJP to seek forgiveness from people for revival of terrorism in Jammu

National Conference Vice president Omar Abdullah on Friday said the deadly terror attacks in otherwise peaceful Jammu region reflects the alleged failure of the BJP which should seek forgiveness from the public of Jammu and Kashmir.

The BJP by blaming NC, Congress and PDP for terrorism in the Union Territory has given a 'clean chit' to Pakistan, he said. "What is the situation of militancy in the Jammu region where our brave force personnel are targeted quite frequently? BJP should first reply why militancy spread to Jammu region after 2014, especially in the last three years when its graph went up," the former chief minister said. "There is not a single place in Jammu where terror attacks have not taken place whether it is Chenab valley, Pir Panjal region, Reasi, Kathua, Udhampur, Jammu and Samba...this reflects their (BJP government's) failure and the party should accept it and seek forgiveness from the people," he said.

Talking to reporters on the sidelines of an election rally in support of party candidate Sunil Verma in Udhampur East assembly segment, Omar referred to the statements of Home Minister Amit Shah blaming NC, Congress and PDP for terrorism and said "when the BJP leaders speak within J&K, they blame us but when they are outside the Union Territory they hold Pakistan responsible". "They (BJP leadership) do

not talk in one voice. If we are responsible, then why are they not talking to Pakistan? You are blaming us (for terrorism) from the soil of J&K, thus giving a clean chit to Pakistan. They are making contradictory statements and taking in different tones to mislead the public," he said. He, however, said the National Conference speaks in one voice within and outside Jammu and Kashmir. Asked about BJP's criticism of his party's manifesto, he said, "What you expect that they will appreciate our manifesto? They are fighting the elections against us and it is evident that they will oppose our manifesto.'

Six terrorist associates arrested in Pulwama **STATE TIMES NEWS**

SRINAGAR: Police have arrested six terrorist associates with arms and ammunition in Pulwama district of Jammu and Kashmir, an official spokesperson said on Friday. Police received specific input that a Pakistan-based Kashmiri terrorist of Jaish-e-Mohammad was in the process of identifying youths who could be motivated to join ter-

ror ranks, the police spokesperson said. Before formally inducting them, such youths were given arms, ammunition and explosives for committing terror acts, according to police.

"During investigation, the youths who were part of this module were identified. It came to fore that the Pakistan-based terrorist with the assistance of an OGW in jail identified many youths who were motivated to join terror ranks in the Tral area of Awantipora and Kulgam district," the spokesperson said. These youths were provided pistols, grenades, IEDs and other explosives. "Before inducting them into terror ranks, they were instructed to do some terror activity either by target killing, throwing grenades on SFs/Public places, non-local labourers and by laying and detonating IEDs," he said.

Police said it also came to light during the investigation that the Pakistan-based handler had chosen a few places for planting IEDs with the assistance of these youths and pumped in money for the execution of the tasks and procuring material for making more IEDs. So far, six terrorist associates have been arrested in the case, the spokesperson said. Based on disclosures made by these accused persons, a large quantity of arms/ammunition and explosives including five IEDs with remotes, 30 detonators, 17 batteries for IEDs, two pistols, three pistol magazines, 25 live rounds of pistol, four hand grenades and Rs 20,000 cash have been recovered, he said.

(Amendment) Act, 2023 will come into force.

Passed by Parliament in the fag end of 2023, the law provides for preparation and publication of lists of touts.

Tout means a person who procures, in consideration of any remuneration from any legal

But at the same time, no one's name will be included in any such list until he has been

practitioner, business from him or her.

All the aspects which are dealt with in the Legal Practitioners Act, 1879 are already covered under the Advocates Act, 1961 except the matter relating to 'touts'. All sections of the Legal Practitioners Act, 1879, except three sections have been repealed through the Advocates Act, 1961.

The Law Commission in its report 'Obsolete Laws: Warranting Immediate Repeal' had also recommended for repealing of the Legal Practitioners Act, 1879 after making suitable amendments to the Advocates Act, 1961.
