Prime Minister to travel to Brunei on a bilateral visit. A joint statement issued after their talks said both leaders "reiterated their commitment to maintaining and promoting peace, stability, maritime safety and security, as well as respecting freedom of navigation and overflight and unimpeded lawful commerce, consistent with international law, notably the UN Convention on the Law of the Sea (UNCLOS) 1982."

It added that the two leaders urged all parties to resolve disputes through peaceful means in accordance with international law, particularly UNCLOS 1982.

Modi described Brunei as an "important partner" in India's 'Act East' Policy and Indo-Pacific Vision, and said his talks with the Sultan included ways to further cement bilateral ties and the two sides are going to further expand trade relations, commercial linkages and people-to-people exchanges.

"India and Brunei have deep historical and cultural ties. This year, we are celebratng the 40th anniversary of our diplomatic ties. On this occasion, we have decided to commemorate our relations as Enhanced Partnership," Modi said.

Their talks covered a range of topics including defence, trade & investment, food security, education, energy, space technology, health, capacity building, culture as well as people-to-people exchanges. They agreed to explore and pursue collaboration in areas such as ICT, fintech, cyber security, new and emerging technologies and

"We had comprehensive talks on various aspects of our ties to give a strategic direction to our partnership. We are committed to strengthening our cooperation in economic, scientific, and strategic sectors. We have decided to strengthen our cooperation in FinTech and Cyber Security along with Agri-industry, pharmaceutical and health sectors," Modi said.

"We discussed the potential for long-term cooperation in LNG. To strengthen our defence cooperation, we held a constructive dialogue on possibilities of cooperation in the defence industry, training and capacity building. To strengthen our cooperation in the Space sector, we have agreed on cooperation in satellite development, remote sensing, and training," he said.

The two leaders also exchanged views on regional and global issues. They condemned terrorism in all its forms and manifestations and called upon states to repu-

They reiterated their commitment to work closely together in mutually beneficial areas to further strengthen the ASEAN-India Comprehensive Strategic

"Reflecting on the excellent progress over the years in bilateral relations, both leaders reaffirmed their commitment to further strengthen, deepen and enhance partnership in all areas of mutual interest," said the joint statement.

Both leaders expressed satisfaction that the historic visit coincides with the 40th anniversary of the establishment of diplomatic relations between the two countries and acknowledged that the deep-rooted friendship between Brunei and India has strengthened in various areas over the past four decades.

They acknowledged that Brunei and India share historical linkages that date back centuries, facilitated by cultural interactions and trade.

Both leaders agreed to further expand bilateral trade and economic ties in areas of mutual interest. They further underlined the importance of regular exchanges and dialogue which should be held through key platforms such as the Joint Trade Committee (JTC) as well as other relevant bilateral, regional, and multilateral

They recognised the importance of food security and agreed to enhance cooperation in agriculture and the food supply chain through the sharing of knowledge, best practices and experience, said the joint statement.

The Prime Minister expressed deep appreciation to Brunei for continuing to host the Indian Space Research Organisation (ISRO)'s Telemetry Tracking and Telecommand Station, which has contributed towards India's ongoing efforts in the

Both leaders agreed to strengthen cooperation at various regional and multilateral for a and work together for enhanced multilateralism reflective of contemporary realities

The two leaders agreed on the urgent need to address climate change and enhance efforts in mitigating the adverse impacts from this rising challenge, in accordance with international climate objectives, such as the Paris Agreement.

Prime Minister Modi thanked Sultan and the entire royal family for the warm welome and hospitality. He invited the Sultan to visit India.

The two sides also signed an MoU on Cooperation in the operation of Telemetry, Fracking and Telecommand Station for Satellite and Launch Vehicles.

Before leaving for Singapore, Prime Minister Modi described his visit to Brunei as 'productive" and said it ushers in a "new era of even stronger India-Brunei ties" conributing to a better planet.

Therefore, in exercise of the powers under sub-section (1) of Section 126A of the R.P. Act, 1951, and considering the provisions of sub-section (2) of the same section, the Election Commission hereby notifies the period between 7:00 A.M. on September 18, 2024 (Wednesday), and 6:30 P.M. on October 5, 2024 (Saturday), as the period during which the conducting, publishing, or publicizing of exit polls by any means, including print or electronic media, or dissemination in any other manner, shall be prohibited in connection with the aforementioned general elections.

Furthermore, it is clarified that under Section 126(1)(b) of the R.P. Act, 1951, displaying any election matter, including the results of any opinion poll or other poll survey, in any electronic media, is prohibited during the 48-hour period ending with the conclusion of polling in connection with the aforesaid general elections.

to be trained and should not be found wanting in any respect. He said that flood response manual should be circulated among all the concerned and should be studied deeply.

Regarding the Decision Support System, CS said that it should be upgraded and supported by Digital Risk Data Base which is an inventory of all the resources, infrastructure etc available in an area so that a proper and coordinated plan is framed and executed in time.

He further called for having a detailed flood mapping/inundation map of each area to act accordingly. He exhorted upon the concerned officers to have proper planning in place to deal effectively with the natural disasters and mobilisation of resources to be done in advance and flood duty charts issued.

Chief Secretary also inquired about the stock position of different flood mitigation items available with the departments in their stores and urged for conducting mock exercises by involving all stake holding departments at ground level.

The Registrar General's note further disclosed that the Chief Justice has from time to time constituted special Benches for prioritizing olds cases, detention and liberty matters and in this regard, vide order dated August 14, 2024, the roster was also modified as per previous practice, whereby inter alia, the subject matters relating to NIA cases for Admission, Orders and Hearing and all Habeas Corpus petitions for Admission, Orders and Hearing were retained by the Chief Justice (Acting) and by virtue of same order, matters which were earlier kept for determination by the Bench headed by The Chief Justice (Acting) have been assigned to a DB presided by one of us (Atul Sreedharan-J), thus certain matters which were earlier kept by the DB-I for determination have been reassigned to DB-II.

Roster dated August 14, 2024 was further modified vide order dated ND D August 22, 2024 and August 23, 2024 respectively, insofar as NIA and Habeas Corpus matters are concerned. However, vide order dated August 30, 2024, the Chief Justice (Acting) constituted a Special Bench comprising of Justice Rajnesh Oswal, and Justice Mohd Akram Chowdhary, in Srinagar Wing of the High Court during the second half of September 5, 2024, for hearing the cases, which included all NIA matters (after notice) for Admission, Orders and Hearing and all Habeas Corpus Petitions (after notice) for Admission, Orders and Hearing.

It is relevant to mention here that before constitution of the Special Bench vide order dated August 30, 2024, the subject matters were being hearing by the DB-I headed by the Chief Justice (Acting) and at the same time, it is clarified that at no point of time, NIA petitions were heard by any Special Bench and for the first time in order to expedite these matters, the NIA matters were considered as separate as same being a matter of liberty and concern for the security of the Country and in view of the sensitivity involved in these matters,, the NIA matters were treated as

separate subject matter so that these matters be dealt speedily and expeditiously. Thus, the factual aspect given in the social media and the newspaper, whereby it was alleged that the roster was shifted in midway from the Bench headed by one of us (Atul Sreedharan-J) was false, malicious and contemptuous as same amounts to interference in the administration of justice. DB observed that the Court is also disturbed by the incorrect factual aspect given in the social media post and also in the newspaper that one of us (Atul Sreedharan-J) had gone on leave on account of the change in roster which is patently untrue as the said Judge had taken a causal leave on 02.09.2024 on account of medical reasons. This misrepresentation, thus, not only misleads the public but also damages trust in the Judiciary.

The reasons given in the social media post as to why one of us (Atul Sreedharan-J) had gone on leave gives an impression that the said Judge went on a protest leave against a change in roster. This also given an impression that the said Judge is interested in getting certain cases of a particular type listed before him and decided. Such is a wrong and probable inference which flows from the article in the social media and also as published in the newspaper of

DB observed that under the circumstances, this Court is of the opinion that the Registrar Judicial be pleased to place this matter before the Chief Justice (Acting) to consider whether this matter should be placed before an appropriate Bench for initiation of criminal contempt against the publishers. It is also requested that the Bench may not have one of us (Atul Sreedharan-J) as part of the controversy relates to him.

Govt signs peace...

an event where a peace agreement was signed between the central and Tripura governments and two insurgent groups of the state here at North block aiming to end violence and bring peace in the northeastern state.

Shah said a new milestone is set today in Tripura's ongoing journey towards peace

and progress with the signing of the agreement. Tripura Chief Minister Manik Saha and senior officials of the Ministry of Home Affairs (MHA) and the state government were also present during the signing of the Memorandum of Settlement with the representatives of National Liberation Front of Tripura (NLFT) and All Tripura Tiger Force (ATTF).

The NLFT and the ATTF have agreed to end a 35-year-long conflict and return to the mainstream, renouncing violence and committing to building a prosperous and developed Tripura, reposing their trust in the Modi government, Shah said.

"The Modi government is committed for the overall development of the Northeast especially the tribal groups, through development while preserving their culture, lan guage and identity," he said.

Shah said the government has given highest priority to peace and development in the northeastern region

"All peace agreements signed in the Northeast has been implemented by the gov

The home minister said the central government has been working tirelessly to fulfil Modi's vision of a developed Northeast, free from extremism, violence and con flict. He said under Modi's leadership, the government has signed 12 important agreements to bring peace and prosperity in the Northeast, of which, three relate to

Around 10,000 people have given up arms and joined the mainstream due to these agreements, he said.

Shah said over 328 insurgents will give up arms and join the mainstream and Re 250 crore has been approved for development of area of operation of the two insur gent groups, particularly pockets dominated by the tribals.
