KISHTWAR: To encourage maximum voter participation in General Election to Legislative Assembly 2024, District Election Officer (DEO) Kishtwar Rajesh Kumar Shavan on Wednesday launched a massive Systematic Voters' Education & Electoral Participation (SVEEP) Programme in the district.

The programme held at Chowgan Ground included multifarious activities aimed at generating Electoral awareness among field functionaries and Students.

The event attracted over 1,500 participants, including Anganwadi Workers (AWWs), ASHAs, students from Government Higher Secondary School Boys, GHSS Girls, Polytechnic College and NCC Scouts from Government Degree College (GDC).

The DEO along with Senior Superintendent of Police (SSP) Abdul Qayoom, besides District Nodal Officer SVEEP (DIO), Dr Kuldeep Kumar; Nodal Officer

Training, Riyaz Ahmed Butt; Nodal Officer SVEEP 49-Kishtwar Assembly Constituency Masood Qazi and Principals GHSS Boys and GHSS Girls, among other officials from the Election and SVEEP Cell were present at the event.

The programme began with a plantation drive, as the DEO along with SSP planting a Chinar tree to signify growth and the importance of environmental stewardship.

maximum voter turnout on September 18, 2024, which is the designated polling day for the district.

Offline Applications on prescribed format are invited from the eligible/desirous candidates seeking admission in PG Diploma in Rehabilitation Psychology (PGDRP)-2024 in Composite Regional Centre, (CRC), Baramulla Srinagar, which should reach to the J&K BOPEE offices Srinagar/Jammu upto 11.09.2024 till 4:00 p.m. The selection of the candidates shall be governed by the J&K Board of Professional Entrance Examinations Act, 2002 and the Rules and Regulations thereunder read with the J&K Reservation Act, 2004 as amended from time to time and as per the Rules thereunder as amended vide SO 176 of 2024 dated 15-03-2024 read with S.O. 305 dated 21.05.2024.

Submission of Application Forms (Offline):

The eligible and interested candidates are required to submit the duly filled in Application Form (Annexure-A) to this Notification available on the BOPEE website and at the BOPEE offices Srinagar/Jammu upto 11.09.2024 (till 4:00 p.m.) during working days along with the payment fee of Rs. 2000/- (Rupees Two thousand only) to be made through PDS machines installed in the BOPEE offices Srinagar/Jammu. The candidates have to submit the following self-attested Certificates (Xerox Copies) along with the Application Form:

- I. Domicile Certificate of UT of J&K and for the candidates of UT of Ladakh, ST Certificate issued by the Competent Authority of Ladakh shall be treated as Domicile Certificate.
- II. Qualifying marks certificate;
- III. Date of Birth Certificate; and
- IV. Reserved category certificate, if any.

The candidates must bring along original certificates for verification by BOPEE office at the time of submission of the application form.

Eligibility:

The eligibility prescribed by the Rehabilitation Council of India for pursuing Post Graduate Diploma in Rehabilitation Psychology course is as under:

- Bachelor's Degree (Regular Mode) with General Psychology Courses in all the three years;
- Master's Degree in any Branch of Psychology either in Regular Mode or Distance Mode;
- Master's Degree in Counselling Psychology either in Regular or Distance Mode with a minimum of 55% marks in aggregate for OM candidates and for SC/ST/Other Reserved Categories, with minimum of 50% Marks in aggregate is essential. Entry qualification shall be from a UGC recognized university.

The admission to this course is subjected to the production of affiliation for the said course from University of Kashmir for the session 2024-25.

Selection Process:

The selection for the said course is purely on merit basis and the criteria adopted by the Board for the last more than three years for the purpose of short listing of candidates for preparation of Merit List is as under:

- 90% weightage on pro-rata basis to the marks obtained in qualifying examination viz Bachelor's Degree/Master's Degree in Psychology as the case may be;
- 10 additional points to the candidates possessing Master's Degree in any branch of Psychology in addition to Bachelor's Degree in General Psychology.

3. In case of tie, Date of Birth of candidate(s) shall be considered i.e. the candidate older in age shall be preferred first. For further tie, the first alphabet of candidate(s) name shall be considered.

Note:

- Candidate must be a Domicile of J&K/Ladakh.
- No under process certificates shall be accepted.
- The information in the Application Form of the candidate shall in no case be construed as an acceptance of that information/category certificate by the BOPEE. Therefore, if at any stage, it is found that a candidate has provided false or incorrect information in respect of any eligibility condition, his/her candidature shall be cancelled without any further notice to a such candidate.
- Candidates having "Outstanding Proficiency in Sports" must submit their certificates to the Secretary, J&K Sports Council, Srinagar/Jammu for awarding sports points which will be then officially submitted to the Board by the J&K Sports Council. Board shall not be responsible where a candidate fails to submit sports certificates to the Council or Council fails to forward sports points of a candidate to the Board. It shall be sole responsibility of the candidate to ensure that his/her sports points are forwarded by Council to the Board. (Candidates belonging to sports category shall be considered on the basis of merit obtained in the Common Entrance Test or on the basis of the marks obtained in the qualifying examination where the Entrance Examination is not held and the sports points given by J&K Sports Council).
- The candidates having more than one reserved category certificate can get benefit of only one category as per his choice in terms of Section 19 of J&K Reservation Act, 2004 indicated in the Application Form which in no case shall be changed afterwards. The candidate, whose category certificate shall be found invalid, such a candidate shall be considered in open merit, if otherwise found eligible, without any further notice.
- In case there is no eligible candidate in any category, the seat of that category shall be allotted to Open Merit Candidates strictly in the order of merit.
- Merit submission of Application Form does not confer any right for admission of the candidates in the College / Center unless and until their eligibility is confirmed by the Board.

Consequent upon the declaration of NEET UG, 2024 re-revised result by the National Testing Agency (NTA) on 26-07-2024, and subsequent Notifications issued by the Board with regard to Registration / verification of documents, filling up of online preferences and other actions including notifying of Sports merit of candidates vide Annexure B of Notification No. 084-BOPEE of 2024 dated 25.08.2024 and after due application of reservation rules as amended from time to time on the basis of merit cum preferences preferred by the eligible candidates through online mode, the list of candidates provisionally selected for undergoing MBBS/BDS Courses-2024 in various Govt. Medical / Govt. Dental / Private Medical Colleges of the UT of J&K, is hereby notified as per Annexure-A to this Notification, which shall be available on the official website of the Board via www.jkbopee.gov.in only.

The candidates shall report to the Colleges allotted to them upto 06-09-2024 till 04.00 p.m. along with the following documents in original:

- 1) Date of Birth Certificate (Matriculation).
- 2) Marks Card of 10+2.
- 3) Domicile Certificate.
- 4) Valid Category Certificate, if any, issued prior to 23.08.2024 by the competent authority.
- 5) Valid Income Certificate in respect of Poor & Backward Category candidates, wherever required.
- 6) NEET Score Card 2024.
- 7) Compulsory Service Bond by the candidates belonging to the UT of Ladakh, and
- 8) Any other document as may be required by the concerned college authorities.

The candidates who have been allotted Government / Private Colleges in accordance with their online preferences and in order of merit, shall mandatorily have to join against their provisionally allotted College / Seat(s) upto 06-09-2024 till 04.00 P.M. positively and in case any candidate who fails to join against his/her allotted seat(s) shall not be eligible to participate in 2nd round of upgradation / allotment counselling under any circumstances.

It shall be sole responsibility of the College concerned to ensure proper check and verification of documents before the candidate(s) is allowed for admission strictly as per NMC (MCI)/DCI guidelines.

After the last date of joining, the unfilled seat(s), if any, shall be communicated to the Board by the College(s) concerned. These unfilled seats and seats against Hindu Minority Quota and NRI Quota seats in ASCOMS shall be filled up in 2nd round of counseling for which the date(s) shall be notified separately.

The Heads of the Colleges/Institutions shall open their respective college including holidays falling up to 06.09.2024 and shall furnish the short fall, if any, to the J&K BOPEE by 06-09-2024 upto 05:00 p.m. to enable the Board to take further necessary action in the matter.

Note:

1. The admission of the candidates is purely provisional and shall be liable to be cancelled in case any information furnished by any candidate proves to be false/ fabricated, and action as warranted under law shall be initiated against such candidates.
2. The seats have been allotted to the candidates as per S.O. 176 dated 15-03-2024 read with S.O. 305 dated 31-05-2024 issued by Social Welfare Department, UT of J&K. The shortfall in horizontal reservations in MBBS and BDS Courses shall be filled through offline mode in 2nd round of counselling.
