Consequent upon the conclusion of 1st round of physical counselling vide Notification No. 083-BOPEE of 2024 dated 22-08-2024 for admission to M.Sc. Nursing Course-2024, the Board has received the shortfall from various Colleges/Institutions of UT of J&K. In order to fill up these seats or the seats remained unfilled after the conclusion of 1st round, it is hereby notified for the information of all the concerned candidates that the Board shall conduct the 2nd / Mop-Up Round of Counselling (Physical) for Admission to M.Sc. Nursing Course-2024 in various Colleges/Institutions of UT of J&K as per the following schedule:

The following procedure shall be followed during 2nd / Mop-Up Round of Physical Counselling:
1. All the eligible/interested candidates are advised to report physically at BOPEE Office Jammu/Srinagar on the above date between 01.00 p.m. to 2.00 p.m. for attendance and registration along with the following documents in original:
I. Domicile Certificate;
II. B.Sc. Nursing / Post Basic B.Sc. Nursing/ B.Sc. Hons. Nursing Marks Card;
III. One Year work experience after B.Sc. Nursing/Post Basic B.Sc. Nursing;
IV. Certificate as a registered Nurse or Registered Midwifery or equivalent with any state Nursing Council;
V. Valid Category Certificate, if applicable;
2. The candidates participating 1st time shall deposit the Counselling fee of Rs.1800/- (Rupees one thousand only) through the PCS Machines available at the BOPEE office Jammu/Srinagar through Debit/Credit cards. Any candidate who fails to deposit the counselling fee shall not be allowed to participate in the counselling process. Further, if any, candidate is not able to participate personally in the counselling on designated day & date of Counselling due to unavoidable circumstances, he/she can authorize his/her close family member who falls in his/her blood relation on the devised format of the Board to participate in the counselling on behalf of the concerned candidate on his/her own risk and responsibility. The said authorized person had to submit the authorization letter along with his Identity Card and Aadhar Card during the process of counselling otherwise he/she shall not be allowed to participate in the counselling.
3. The seats shall be allotted to the candidates as per S.O. 176 dated 15-03-2024 read with S.O. 305 dated 31-05-2024 issued by Social Welfare Department, UT of J&K. It is further enjoined upon all the concerned candidates to ensure the validity of the Category Certificate, which in any case should not have been issued after 15.06.2024 i.e. the last date fixed by the Board for filling up of online application forms for M.Sc. Nursing Courses, 2024 vide Notification No. 027-BOPEE of 2024 dated 15.06.2024.
4. The Board shall first conduct the counselling of reserved category candidates and in case any category seat(s) remained unfilled, the same seats shall be converted into Open Merit as per Section 09 of J&K Reservation Act 2005 and accordingly shall be filled on the same day strictly on the basis of merit cum preferences preferred by the candidates present during the Counselling process.
5. The candidate(s) who have been allotted Seat(s) during the Second Round of counselling, but have failed to join or have resigned against the said allotted seat/College, he/she is also eligible to participate in the Mop Up Round of counselling.
6. Those candidate(s) who have been allotted seat(s) during First Round of Counselling & have joined on the respective allotted seat & Institutions & are interested for upgradation of his/her seat can participate in this 2nd / Mop-Up Round of Physical Counselling with the condition that he/she shall have to produce his/her fee deposition receipt of the concerned allotted College at the time of Registration/Attendance on his/her day/date of counselling, otherwise he/she shall not be allowed to participate in the Counselling process.
7. Candidate(s) who has / have opted for C.N.A. / S.N.A. or who could not attend counselling due to unavoidable circumstances are also eligible to attend the 2nd / Mop-Up Round of Physical Counselling for up-gradation / allotment of seats in M.Sc. Nursing Course.
8. The candidate(s) participating in this physical round of counselling and allotted a seat, should in their own interest not to leave the Board office as there is a possibility that a seat of his/her choice, which was not available on his/her turn of counselling may become available during the process, he/ she can stake a claim on such a seat immediately once the seat is displayed in the seat matrix on the monitor of the Board, consequent upon its vacation by a candidate so that such a candidate is considered for allotment of the seat on merit cum preference basis. The seat allotted to him/her earlier shall become vacant and be added to the seat matrix.
