Highlighting the critical importance of the highway, the Chief Minister noted that NH-44 has suffered unprecedented damage in both Ramban and Udhampur districts, causing severe disruption to traffic and supplies.

He assured that every possible effort is being made to expedite restoration works and minimize public hardship.

In the last few months, both sides have initiated a series of measures to reset their ties that came under severe strain following the deadly clashes between Indian and Chinese troops in Galwan Valley in June 2020.

Modi, who landed in China last evening after a gap of seven years, said in the meeting that an atmosphere of peace and stability has been prevailing along the border since he and Xi met in October last year in the Russian city

"Both leaders welcomed the positive momentum and steady progress in bilateral relations since their last meeting in Kazan in October. They reaffirmed that the two countries were development partners and not rivals, and that their differences should not turn into disputes," the MEA said.

"A stable relationship and cooperation between India and China and their 2.8 billion peoples on the basis of mutual respect, mutual interest and mutual sensitivity are necessary for the growth and development of the two countries, as well as for a multipolar world and a multi-polar Asia befitting the trends of the 21st century," it said.

It said the two leaders noted with satisfaction the suc cessful disengagement of troops last year and the maintenance of peace and tranquility along the border areas since

"They expressed commitment to a fair, reasonable, and mutually acceptable resolution of the boundary question proceeding from the political perspective of their overall bilateral relations and the long-term interests of the two

The terrorist was introduced to other policemen as a member of the Special Operations Group (SOG), Lalpora, a ploy used by the SHO to conceal his true identity. Witnesses later testified that Wani was seen personally guiding the terrorist to deboard near the SBI branch, moments before the bloodbath unfolded.

In 2011, the Sessions Judge, Kupwara, acquitted both Wani and his Munshi, citing contradictions in witness testimonies regarding whether the terrorist wore police or army uniform. The trial court held that the prosecution failed to conclusively establish the conspiracy.

However, the State filed an acquittal appeal in 2011 arguing that the trial court had ignored clinching evidence. After a protracted hearing, the High Court reserved its judgment on July 30, 2025, and pronounced it on August

The Division Bench meticulously analyzed the testimonies of prosecution witnesses Constable Ayaz Ahmad, Constable Riyaz Ahmad, and Ali Mohammad Mir (the official driver), all of whom consistently stated that Wani knowingly facilitated the terrorist's travel from Sogam to

The Bench also noted that uniform belonging to Constable Sumandar Khan, who was on leave at the time had been stolen, and the same was later recovered from the slain terrorist. This, the Court said, corroborated the prosecution case that the terrorist was camouflaged in police attire with the help of the SHO.

Rejecting the trial court's reasoning, the judges ruled that minor contradictions about the type of uniform could not overshadow the overwhelming evidence of conspiracy.

"The respondent was duty-bound to protect lives and property of security personnel but instead became their tormentor by consciously allowing the terrorist to unleash mayhem," the Bench observed.

Holding Wani guilty of criminal conspiracy (Section 120) B RPC) and murder (Section 302 RPC), the Division Bench ruled that he was equally responsible for the killings carried out by the terrorist.

However, the Court found no direct evidence against coaccused Abdul Ahad Rather (Munshi) and upheld his acquittal.

Consequently, the High Court convicted Wani and sentenced him to imprisonment for life, directing him to surrender before the trial court to undergo the sentence.

Police blows lid off woman lawyer's plot to frame ex-husband in terror case

SRINAGAR: Jammu and Kashmir Police on Sunday blew the lid off an alleged conspiracy hatched by a woman lawyer with the help of her two accomplices to frame her ex-husband in a terror case in Baramulla district, officials said.

The case was cracked during a probe into the recovery of a fake improvised explosive device (IED) near the main gate of Manzoor Ahmad Khan's house at Mahayan-Ferozpora in the Tangmarg area on July 31, a police spokesman said.

Acting on an input about the suspicious object, police, in collaboration with security

agencies, launched a cordon and search operation in the

A bomb disposal squad was summoned, and upon inspection, the object was found to be a plastic box designed to resemble an IED, the spokesman said, adding that it was later confirmed to be a fake IED that posed no explosive threat.

The investigation led to the apprehension of the prime suspect, Sajad Ahmed Ganie from Nowgam village in Sumbal, who planted the fake IED and had gone into

During interrogation, Ganie confessed to planting the fake IED at the behest of

advocate Rahila Qadri, wife of advocate Rayees Ahmed Bhat from Pandithpora-Tangmarg, the spokesman said. It was revealed that Qadri, the former wife of Manzoor Ahmad Khan, conspired to falsely implicate the latter in a fake terror case in connivance with her present husband.

"Due to a long-standing matrimonial feud, Qadri harboured deep grudges against her ex-husband and orchestrated the conspiracy to frame him. The accused (Ganie) deliberately provided false information to police in an attempt to implicate Khan in a fabricated case," the spokesman said.

Soldier dies in accidental fire
