Subject: Compliance with Hon'ble Supreme Court's order dated 22nd August 2025 and Animal Birth Control (ABC) Rules, 2023.

Circular No. 07-JK (HUD) of 2025
Dated: 05-09-2025

In pursuance of the Hon'ble Supreme Court's order dated 22.08.2025 in *Suo Moto Writ Petition (Civil) No(s). 5 of 2025* and for strict implementation of the Animal Birth Control (ABC) Rules, 2023, notified vide G.S.R 193(E) dated 10th March, 2023 under Prevention of Cruelty to Animal Act, 1960, all Urban Local Bodies of Jammu and Kashmir are hereby directed to take immediate action, on the following points:

A. Designated Feeding Sites for Community Dogs
In accordance with Rule 20 of the Animal Birth Control (ABC) Rules, 2023, as well as the directions of the Hon'ble Supreme Court, every Urban Local Body (ULB) shall immediately initiate the process of identification and establishment of designated feeding sites for community dogs in each municipal ward. This identification must be undertaken in consultation with local residents, feeders, and caregivers familiar with the dog populations, ensuring that the sites are selected in a manner consistent with the territorial distribution of the dogs. Care shall be taken to locate such feeding points away from children's play areas, staircases, entry and exit points, or other high-footfall zones where children and elderly citizens are likely to gather. Once identified, each site be clearly demarcated through installation of a permanent notice board or gantry explicitly notifying that feeding of community dogs shall only be carried out at the designated area. However, until such formal identification and notification of feeding sites is completed, caregivers shall not be prevented from feeding community animals responsibly at safe and clean locations, and they shall also ensure proper disposal of food waste so that hygiene and public health concerns are not compromised.

B. Other key Provisions of Animal Birth Control (ABC) Rules, 2023 for compliance
1. Infrastructure and Shelter Management (Rule 10):
ULBs must ensure the identification, construction, and maintenance of adequate Animal Birth Control Centers and shelters. These facilities must be equipped with sufficient kennels, operational theatres, quarantine areas, and isolation kennels. It is mandatory to install Closed-Circuit Television (CCTV) cameras across the premises, with a specific focus on operation theatres and animal housing areas, and to maintain video footage for at least one month. Furthermore, ULBs are responsible for ensuring high standards of cleanliness, hygiene, and proper record-keeping of all animals admitted, treated, and released.
2. Humane Animal Handling and Capture (Rule 11):
The capture of street dogs must be conducted using only humane methods such as net catching or hand catching. The use of any harmful devices like tongs, wires, or ropes is strictly prohibited. Capture operations must be pre-announced to the local residents via banners or public notices. Each dog-catching team must comprise a driver, at least two trained employees of the ULB or an Animal Welfare Organisation, and a representative from an AWO, all of whom must carry valid identity cards. Importantly, lactating female dogs and puppies under the age of six months shall not be captured for sterilization.
3. Project Allocation and NGO Engagement (Rules 3, 4, & 5):
ABC programs can be conducted by engaging a recognised Animal Welfare Organisation (AWO). Crucially, work must be allotted only to AWOs that hold a valid Certificate of Project Recognition from the Animal Welfare Board of India (AWBI). NGOs that are blacklisted or have been refused recognition by the AWBI must be strictly excluded from the tender process. The rates prescribed by the AWBI for sterilization and vaccination procedures must be followed.
4. Monitoring and Oversight (Rule 9):
Each ULB is required to constitute a Local Animal Birth Control Monitoring Committee, as given in Schedule II.
5. Record Keeping and Reporting (Rules 12 & 13):
Meticulous and daily updated records must be maintained at every ABC center. ULBs, or the engaged AWO, must submit monthly progress reports and an annual report to the State Monitoring Committee and the AWBI, detailing the number of animals sterilized, vaccinated, and other relevant metrics as per the schedules in the Rules.
6. Management of Sick, Injured, and Rabid Dogs (Rules 11, 15, & 16):
Sick or injured dogs must be provided with adequate treatment and separated from healthy animals. In cases of suspected rabies, Standard Operating Protocol, as given in the rules, must be strictly followed. Carcasses of rabid dogs must be disposed of, as per guidelines.
7. Grievance Redressal (Rule 18):
All complaints regarding the implementation of the ABC program, violations of the Rules, or instances of cruelty must be promptly inquired into by the ULB.

C. Protection of Caregivers
It is reiterated that harassment, intimidation, or obstruction of caregivers, particularly women, engaged in responsible feeding of community animals, is strictly prohibited. Any such act will be viewed seriously and may invite penal consequences under Section 351 (criminal intimidation) of the Bharatiya Nyaya Sanhita, 2023, in addition to action under other applicable laws.
The Commissioner, Municipal Corporation, Jammu/Srinagar and Director, Urban Local Bodies, Kashmir/Jammu shall ensure that a compliance report, covering all the directions contained herein, is furnished to this Department within thirty (30) days. It shall be the responsibility of all concerned officers of municipal bodies to thoroughly study the provisions of the ABC Rules, 2023, and take immediate steps to implement the same in letter and spirit. Any lapse, delay, or failure in compliance will invite strict action under the relevant rules.
