Emphasizing the critical role of the power sector, Omar Abdullah said, "This is the only way to change the financial situation of Jammu and Kashmir. We should generate electricity and sell it to other regions, especially when their production is ow. But to achieve this, we must first bring down losses in the power sector."

Highlighting the challenges of hydropower vis-à-vis renewable energy, he said, The installed cost of hydroelectricity is very high, though the per-unit cost reduces over time. With solar power now available at Rs. 2 to Rs. 2.5 per unit, competing becomes difficult. But hydropower remains our only viable resource, and we must continue developing projects alongside improving efficiency.

The Chief Minister reaffirmed that tariff rationalisation should be guided by peoble's capacity to pay, ensuring that the rich contribute more while the poor pay less. He assured the engineers that their demands and suggestions would be taken up in earnest, adding that by next Engineers' Day, "there should be no need for you to repeat the same demands.

Explaining his decision to personally retain the Power portfolio, Omar Abdullah said, "I chose to hold this department because if we really want to make J&K prosperous, the most important sector is the Power Development Department. I request you to maintain the momentum in reducing losses and improving efficien-

waqf properties and ruled on the issue of non-Muslim participation in Waqf

The bench, therefore, directed the Central Waqf Council not to have more than our non-Muslim members in the total composition of 20 besides asking state waqf poards to have not more than three such members in the total of 11.

"The following part of clause (r) of Section 3 of the Amended Waaf Act 'any person showing or demonstrating that he is professing Islam for at least five years shall stand stayed until the rules are framed by the State Government for providing a mechanism for determining the question as to whether a person has been practicing Islam for at least five years or not," the top court held.

The top court further stayed a provision which said a property should not be treated as "waqf property till the designated officer submits his report"

In addition, another provision stating, in case the designated officer determines the property to be a government property, he should make necessary corrections in revenue records and submit a report to the state government, was also stayed.

"Unless the issue with regard to title of the waqf property in terms of Section 3C of the Amended Waqf Act is not finally decided in the proceedings initiated under Section 83 of the Amended Waqf Act by the tribunal and subject to further orders by the high court, neither the waqfs will be dispossessed of the property nor the entry in the revenue record and the records of the board shall be affected," it held.

Till the final determination about the title of a disputed property by the tribunal and subject to further orders of the high court in an appeal, the bench held, no third-party rights would be created.

It, however, did not stay Section 23 (appointment of chief executive officer and his term of office and other conditions of service) of the amended law, but directed the authorities "as far as possible" an effort should be made to appoint the chief executive officer of the board who is the ex-officio secretary from the Muslim com-

The bench clarified its directions were prima facie and interim in nature, and would not prevent the petitioners or the government from advancing full arguments on the constitutional validity of the law during the final hearing.

According to the Act, Waqf refers to an endowment made by a Muslim for charitable or religious purposes, such as building mosques, schools, hospitals, or other public institutions.

"Another defining feature of a Waqf is that it's inalienable- which means it cannot be sold, gifted, inherited or encumbered," it said.

On the issue of the law's validity, the bench referred to precedents and said, "Courts should be very slow in granting interim relief by way of staying the provisions of an enactment. Interim relief of such a nature can be granted in rare and exceptional cases...

The verdict underlined courts' acceptance of the legal position of presumption always being in favour of constitutionality of an enactment and the burden being on the person who "attacks it" to show a clear transgression of the constitutional principles.

The order referred to legislative history since 1923 when the Mussalman Wakf Act of 1923 was enacted.

"Since the menace of mismanagement of the wakf properties was noticed by legislature, an enactment was found to be necessary as early as in the year 1923," it

While it did not find fault with the provision requiring a person practising Islam for five years to create a waqf, saying it cannot be called arbitrary, the bench held, 'Since no mechanism or procedure has been provided as of now for ascertaining as to whether a person has been practising Islam for at least five years or not, such a provision cannot be given effect to immediately," it said.

On registration of waqf, it said if mutawallis (caretaker of waqf) have chosen not to get it registered for 30 long years, then they couldn't be heard to say the provision which now required the application to be accompanied by a copy of the waqf deed was arbitrary.

The Chief Secretary sought a detailed appraisal from the Divisional

Commissioner, Jammu regarding the present status of NH-44. He was informed about the partial restoration of traffic on a single-lane stretch that had been severely damaged by flash floods, as well as diversion of vehicular movement through Mughal Road.

The Chief Secretary also took note of the number of vehicles crossing daily and emphasized the need to expedite restoration works so that traffic flows smoothly on both lanes in the shortest possible timeframe.

He directed that the restoration process be closely monitored at the divisional and district levels, with daily reports to be submitted on both traffic movement and progress of repair works.

Acknowledging the critical importance of NH-44 as the lifeline of J&K, the Chief Secretary stressed the need to prioritize movement of trucks carrying essential commodities. He instructed that fruit-laden trucks from the Valley vehicles carrying perishable food items from Jammu, and petroleum and LPG tankers be

given precedence to prevent any shortage of supplies Taking stock of the availability of fuel and foodgrains in the valley, the Chief Secretary was assured by the Commissioner Secretary, FCS&CA that the stock position was comfortable and sufficient. It was further informed that additional supplies of petroleum products and essential foodgrains have started reaching the valley since the partial reopening of the highway. The Chief Secretary also reviewed the arrangements for transportation of apple produce through parcel trains from the Valley to markets outside J&K. He instructed the Divisional Commissioner, Kashmir to ensure that produce from all apple-growing areas is ferried smoothly through this rail link. He further directed that fruit growers and traders be provided full assistance so that they can transport their produce without any hindrance, thereby safeguarding their economic interests during this har-

Reiterating the urgency of fully restoring NH-44, the Chief Secretary impressed upon the NHAI to mobilize all available resources and ensure completion of repair and restoration works within the shortest possible time. He emphasized that meticulous use of every working hour was essential, given the highway's critical role as the primary connectivity corridor linking Kashmir with the rest of the country.
