In case a subscriber is unable to submit the UPS request online through the CRA system due to any reason, including non-availability of the online platform or technical issues, they may submit a duly filled physical application form to their concerned Nodal Office on or before the due date, the ministry said in a separate statement.

Around 31,555 central government employees had opted for the UPS till July 20, and the last date to enrol under the scheme is September 30.

Also, the Finance Ministry, on August 25, introduced a onetime one-way switch facility from the newly introduced UPS

The Finance Ministry said it has been decided that a onetime, one-way switch facility from UPS to NPS will be made available to all Central Government employees who have

"This switch facility may be exercised by UPS optees any time not later than one year prior to the date of superannuation or three months prior to the deemed date of retirement in ease of voluntary retirement, as applicable," it added.

The government has extended the benefit of 'Retirement gratuity and Death gratuity' under UPS.

Further, the government employees who opt for UPS under NPS will also be eligible for the option to avail benefits under the CCS (Pension) Rules, 2021, or the CCS (Extraordinary Pension) Rules, 2023, in the event of death of the government servant during service or his discharge on the ground of invalidation or disablement. The government has also extended tax benefits to UPS as are available to NPS under the Income

"Have the quotas for SCs, STs and OBCs been tinkered vith? I can assure you that as long as there is even one BJP member in Parliament, reservations cannot be scrapped," said

The remarks may be seen in the backdrop of attempts by the BJP, traditionally seen as "a party of the upper castes", to reach out to the numerically powerful deprived castes.

Shah began his more-than-20-minute-long speech by recalling a conversation he had with a journalist earlier in the day

"I was asked why I was holding a workers' conclave instead of a rally where the common people could come? I replied that this is because, unlike the other parties, which depend on leaders for winning elections, ours is a workers-driven organisa-

tion." he said. Shah said it is only in the BJP that a grassroots worker can aspire to rise to the top.

"I had myself started off as a booth-level worker and went on to become the national president," he said.

The workers present at the conclave were drawn from 10 districts of the Magadh-Shahabad region.

Shah noted with concern that the NDA's performance in the ast assembly polls was "not up to the mark" and exhorted the party workers to ensure "an 80 per cent strike rate for our-

selves as well as our alliance partners". June 22, 2025, and remained in judicial custody at District Jail Amphalla, Jammu. Their 90-day remand was set to expire on September 19, 2025.

Public Prosecutor Chandan Kumar Singh submitted that investigation is at a crucial stage, with several witness statements under Section 183 BNSS yet to be recorded. The NIA cited recovery of Pakistani phone numbers from the accused. forensic reports awaited from CFSL Chandigarh and NFSU Gandhinagar, and DNA profiling of seized blankets, shawls, and bedsheets to establish links with slain terrorists. Arms and ammunition recovered in a July 28 encounter were also under forensic analysis.

Defence counsel Ashwani Kumar opposed the extension, arguing that the accused had already been in custody for two months without conclusive evidence, and that the NIA had failed to complete investigation within the time granted.

Rejecting the defence plea, the Court noted that the allegations were grave and directly linked to national security. Citing pending forensic reports and crucial witness statements, the Court ruled that the investigation could not be completed within the statutory 90 days and allowed a 45-day extension of remand. The Judge observed that "a prima facie case is made out for extension of remand and detention of accused beyond the stipulated period," directing the investigating officer to complete the probe expeditiously.


