Using criminal law for vengeance

JAMMU: The High Court of Jammu & Kashmir and Ladakh has quashed an FIR filed in Nowshera against an 85-year-old man and his sons, ruling that the allegations stemmed from a family property feud and were a blatant misuse of criminal law to settle personal scores.

Justice Rajesh Sekhri, while allowing CRM(M) No. 786/2022 filed by Nanak Chand and others, observed that the complainant, daughter-in-law of the petitioner, had attempted to give a civil dispute a criminal colour, and that such "malicious litigation" could not be permitted.

The complainant alleged that after locking her house and leaving with her husband, she returned to find the petitioners had broken in, assaulted her, tore her clothes, outraged her modesty, and stolen gold and cash. On this basis, FIR No. 208/2022 was registered under Sections 457, 382, 354, 427, 323, and 506 of the IPC at Police Station

The petitioners argued that the FIR was fabricated to exert pressure on Nanak Chand, who had earlier cancelled a power of attorney and will deed executed in favour of his eldest son (the complainant's husband) and further disinherited him through a registered deed in 2018.

cannot be allowed: HC They contended that the allegations were improbable, pointing out that one son was serving in the CRPF in Jharkhand, while another was settled in Manali, away from the scene of the alleged crime. The petitioners claimed the FIR was part of a larger effort by the complainant and her husband to reclaim property rights revoked by the elderly

Justice Sekhri noted that while police investigations cannot normally be halted at the threshold, courts are empowered under Section 482 CrPC to intervene when proceedings are patently malicious.

"Allegations that an 85year-old father-in-law, along with his sons, assaulted the complainant, tore her clothes, outraged her modesty and stole ornaments are not only absurd and inherently improbable, but are actuated with

He added that criminal law must not be misused as a tool for vengeance in personal or family disputes.

The court held that the case was essentially a domestic feud over property rights wrongly projected as a criminal offence. It ruled that the FIR had been filed "to wreak vengeance" and "feed fat the grudge" of disinheritance, and therefore ordered its quashing along with all proceedings arising from it.

Bharatiya Nagarik Suraksha Sanhita (BNSS), and Bharatiya Sakshya Adhiniyam (BSA). Replacing colonial-era legislation, the new framework seeks to deliver faster justice, empower victims, strengthen technology use, and safeguard citizens' rights.

about legal provisions but about transforming justice delivery to make it faster, more accessible, and responsive, including for citizens in remote Ladakh," he stated.

# Eligible contractual lecturers to be regularized under 2010 Act: HC

JAMMU: In a landmark ruling that offers major relief to hundreds of contractual teachers in Kashmir, the High Court of Jammu & Kashmir and Ladakh has held that lecturers engaged on academic arrangements, if found eligible, are entitled to regularization under the J&K Civil Services (Special Provisions) Act,

A Division Bench comprising Justice Sanjeev Kumar and Justice Sanjay Parihar, while deciding a series of petitions and appeals including, ruled that posts held by such lecturers must be protected. The court directed that in cases where petitioners qualify for regularization, those substantive posts will be withdrawn from the impugned recruitment advertisements, provided they have not already been filled.

The petitions arose after the government issued advertisements inviting applications for engagement of Lecturers and Teaching Assistants on purely academic arrangements in Kashmir Division colleges. Petitioners argued

that fresh hiring was arbitrary and overlooked their long-standing service and right to regularization under the 2010 law.

The Bench clarified that its directions in WP(C) No. 416/2024 and connected matters would govern the disposal of these cases. This ensures uniformity in handling disputes related to contractual teaching staff across the Union

Alongside the writ petitions, several contempt cases were also pending, alleging non-compliance with interim relief orders. However, the court observed that since the main writ petitions and appeals had been finally disposed of, the interim directions had merged with the final

Accordingly, contempt petitions including CCP(D) Nos. 09/2020, 10/2021, 76/2024 and 17/2025 were closed. One contempt petition-CCP(S) No. 257/2022-arising from an earlier Single Bench order, was directed to be listed before the concerned roster bench on

# Termination without enquiry unconstitutional: HC

JAMMU: The High Court of Jammu & Kashmir and Ladakh has reinstated a young Special Police Officer (SPO) from Kishtwar, ruling that termination without enquiry or notice is unconstitutional and contrary to the principles of natural justice. Justice M.A. Chowdhary, while delivering judgment in WP(C) No. 270/2020, quashed the disengagement order issued against Tyed-ul-Firdous (24), resident of Puchhal, Kishtwar, who had been removed from service in October 2018 after serving more than four years as an SPO. Firdous was appointed as an SPO in August 2014 and served with the district police until October 2018, when he was suddenly removed on allegations of prolonged unauthorized absence. He challenged the disengagement, contending that no show cause notice or departmental enquiry was conducted before action was taken, making the order arbitrary and violative of his constitutional rights. The court empha-

sized that under Section 19 of the J&K Police Act, 1983, SPOs enjoy the same powers, privileges, protections and liabilities as ordinary police officers. When read with Rule 359 of the J&K Police Rules, 1960, this requires that no police officer can be dismissed or removed without being given a reasonable opportunity to

defend himself. "The disengagement of the petitioner without enquiry or notice is not legally and constitutionally permissible... Such action is arbitrary, illegal and unconstitutional," Justice Chowdhary observed. The court set aside the disengagement order and directed that Firdous be reinstated as SPO. However, it clarified that he would not be entitled to honorarium for the intervening period of disengagement. At the same time, the Bench granted liberty to the authorities to initiate proper disciplinary proceedings against him, if necessary, but directed that any such enquiry must be completed within two months.

JAMMU: Nearly three decades after a gruesome killing at Batote, the High Court of Jammu & Kashmir and Ladakh has overturned the conviction and life sentences of three men, ruling that their guilt could not be sustained once the principal accused had been acquitted.

A Division Bench comprising Justice Sanieev Kumar and Justice Sanjay Parihar allowing the appeal filed by Mohd. Akhter, Shafiq Ahmed, and Mohd. Sadiq, all residents of Batote, Ramban dis-

The case dates back to July 2, 1995, when Narsingh Dev was shot dead while sleeping inside his Maruti car near a tea stall at Batote. According to the prosecution, the attack-

Batote killing, acquits three ers arrived in a Maruti van, armed with an AK-56 rifle and pistols. While the main assailant, Tanveer Ahmed, allegedly fired the fatal shots. the three appellants were accused of facilitating the attack by surrounding the

vehicle and preventing escape. In 2004, the trial court convicted the appellants under Sections 302, 149, and 120-B RPC, sentencing them to life imprisonment and a fine of ?5,000 each. Meanwhile, three co-accused who had absconded initially were later acquitted in 2017, a verdict upheld by the High Court in

The Bench noted the inconsistency of convicting alleged facilitators when the main assailants had already been acquitted on the same eviof evidence, the main assailants stood acquitted... the conviction of the coaccused on the same evidence would not sustain," the judges observed.

The court also rejected the State's reliance on conspiracy charges, pointing out that no such charge was framed in the charge-sheet, and the acquittal of co-accused effectively ruled out that theory.

Allowing the appeal, the High Court set aside the convictions and sentences of the three appellants and discharged them of their bail bonds. The court also declined the criminal reference for confirmation of their life terms. bringing closure to one of the region's longest-running criminal trials.
