Whereas it appears to the Government of UT of Jammu and Kashmir that the Land is required in the Jurisdiction of Jammu & Kashmir, for public purpose for construction of Data Recovery Centre at Gladni Grid Station Narwal Jammu. It is hereby notified that land in the area specified is likely to be required for the above purpose.

Whereas a committee was constituted in terms of section (4) of the Jammu & Kashmir Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act 2013, vide order No: 01/CLA(JPDCL/IT&C Division) of 2025 Dated 19-06-2025 for Preliminary investigation for determination of Social Impact and public purposes. The committee in its report submitted that during spot visit it is found that land measuring 06 Kanal 05 Marlas situated at village Narwal Bala, Tehsil Bahu, District Jammu is most appropriate and suitable for already constructed Data Recovery Centre at Gladni Grid Station Narwal.

Whereas in terms of Rule 8 of The Jammu and Kashmir Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement (Social Impact Assessment and Consent) Rules, 2023, the report of the above-said committee is considered as SIA (Social Impact Assessment) report as there is no displacement or rehabilitation involved.
