

JAMMU: The PHD Chamber of Commerce & Industry (PHDCCI), Jammu Region, in collaboration with the Hotel & Restaurant Association, Katra (HRAK), has strongly urged authorities to announce immediate relief measures for the hospitality and allied sectors, which have been severely impacted by recent distur-

A joint delegation, led by PHDCCI Chairman & HRAK President Rakesh Wazir and HRAK Chairman Shyam Lal Kesar, met with Ashok Gupta, General Manager & Divisional Head Jammu, J&K Bank, in the presence of Zonal Head Jammu Anita Nehru and that the 22-day suspension of

& Divisional Head Jammu, J&K Bank. Cluster Head Jammu Arjun Singh Rathore. During the meeting, the delegation expressed gratitude to J&K Bank for unveiling the Rehabilitation Package-2025 for borrowers affected by the ongoing turmoil, which had earlier been proposed by HRAK.

Addressing the delegation, Wazir highlighted the severe challenges faced by the hospitality sector, citing the Pahalgam attack, Indo-Pak tensions, continuous landslides, and tragic incidents at Shri Mata Vaishno Devi Ji and Machail Temple, which resulted in loss of lives and disrupted business operations. He noted

defaulting on loans. While welcoming the bank's rehabilitation package, which includes extended repayment

periods and additional working capital loans, Wazir emphasized that the condition requiring loan accounts to be nonoverdue as of April 21, 2025, should be relaxed. "Borrowers with one or two overdue installments must also be included in relief measures," he stated. He further urged other banks to introduce similar rehabilitation schemes and provide temporary repayment relaxations to units not opting for the pack-

Kesar called upon government departments dealing with electricity, water, GST, and other services to announce corresponding relief and rehabilitation measures. He also urged the government to implement a special amnesty scheme for commercial consumers, similar to that for domestic users, along with a comprehensive package to safeguard the survival of businesses during this

propriate but deeply offensive to the religious beliefs of the Hindu community. Warning shopkeepers, he said Shri Hindu Takht will ensure the closure of any such establishments that attempt to operate during the festival. Tarseem Sharma, State President, remarked that it is the responsibility of every individual to uphold religious traditions and that embracing satvik (pure) practices during Navratri is a spiritual necessity.

Narendra Singh, State Vice President, reinforced this stance, warning that any act which offends the sentiments of the Hindu community will not be tolerated.
