"The subjective satisfaction of the detaining authority, once based on relevant material, cannot be substituted by judicial opinion." the Court ruled.

Similarly, the detention of Ashwani Kumar alias Rinku of Samba under the Prevention of Illicit Traffic in Narcotic Drugs and Psychotropic Substances Act (PIT NDPS Act) was upheld. Despite being on failed to deter him and his activities posed a grave threat to youth and society. Preventive detention, it said, was justified in such circumstances.




