

The committee visited the spot and conducted enquiry regarding the land under acquisition and submitted its report with following recommendation:-

"During spot visit it is found that there is no rehabilitation or resettlement involved in the instant case of acquisition. There is no adverse social or environmental impact of the acquisition. The type of land proposed for acquisition is "Hall and Gair Mumkin". The proposed land acquisition fully serves the public purpose i.e. Construction of Govt. High School at village Samotha Tehsil and District Samba.

The report of the above said committee is considered as SIA (social Impact Assessment) report in terms of Rule 8 of the Jammu and Kashmir Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement (Social Impact Assessment and Consent) Rules, 2022, as there is no displacement or rehabilitation involved in instant case of acquisition of land measuring 02 Kanal 10 Marla for the above said project in the village Samotha Tehsil Samba District Samba.
