delayed though the electoral college was in place nearly a year ago following the assembly polls in the Union Territory.

"Today, the Election Commission of India has announced elections to four Rajva Sabha seats that have remained vacant till now. It is the right decision, though a delayed one. We welcome it," Congress chief spokesperson Ravinder Sharma told PTI.

He pointed out that assembly elections in Jammu and Kashmir were held a year ago and the electoral college was in place, yet the UT remained unrepresented in the Rajya Sabha for over a year. "Dair aaya, durust aaya (better late than never)," he said.

Sharma said the party leadership will soon meet to deliberate on the matter: "We will take the right decision in consultation with our central leadership," he added.

Reacting to the announcement of the poll schedule, BJP spokesperson Zorawar Singh Jamwal said, "The Election Commission announced elections for four vacant Rajya Sabha

seats today. It is a welcome step." "These new MPs, once elected, will raise issues related to the welfare of the people of Jammu and Kashmir and the development of

the region in Parliament," he said. The Union Territory has been unrepresented in the Upper House of Parliament since February 15, 2021, the day when Ghulam

Nabi Azad and Nazir Ahmed Laway finished their term. Two other members, Fayaz Ahmed Mir and Shamsher Singh Manhas, had completed their term on February 10 in the same

According to the Jammu and Kashmir Reorganisation Act, four members of the Rajya Sabha were to represent the UT, but the seats remained vacant after the expiry of the previous members'

terms due to the absence of the required electorate at that time. With the constitution of the J-K Legislative Assembly, the elecorate is now in place to conduct the biennial elections, the EC said.

The counting of votes will take place on October 24, an hour after

The morning began with a complete shutdown in the Ladakh capital and hundreds of people took to the streets. As the day progressed, flames and dark smoke clouds could be seen from afar.

The police resorted to firing and teargas shelling to bring the situation under control after the protesters indulged in widespread ziolence, officials said

The Ladakh Apex Body (LAB) youth wing called for the protest after two of the 15 people, who were on a 35-day hunger strike since September 10, were shifted to a hospital because their condition deteriorated on Tuesday evening.

Congress leader and councillor Phuntsog Stanzin Tsepag was booked for allegedly making a provocative speech at the hunger strike venue on Tuesday.

The BJP alleged that the violence was a part of the Congress' nefarious design to create situations in the country similar to Bangladesh, Nepal and the Philippines

"Today in Ladakh, an attempt was made to portray some protests as being led by 'Gen Z' but when an investigation was carried out, it was found that this was not a Gen Z protest but actually a Congress protest," BJP MP and national spokesperson Sambit Patra told reporters in Delhi.

The fast was to push the Centre to resume dialogue in support of their four-point demand - statehood, extension of the Sixth Schedule, separate Lok Sabha seats for Leh and Kargil and reser-

Addressing an online press conference, Wangchuk said the fact nat Tsering Angebuk (72) and Tashi Dolma (60) were taken to s hospital was most likely the immediate trigger for the violent

With the situation worsening rapidly, he stepped in with an appeal and an announcement that he was cutting short the fast.

"I request the youth of Ladakh to stop the violence forthwith as it only causes harm to our cause and further deteriorates the situation. We do not want instability in Ladakh and the country," he told his supporters.

Teargas shells were heard in the backdrop.

"This is the saddest day for Ladakh and for myself personally because the path we are treading for the last five years was peaceful... We held hunger strikes on five occasions and walked from Leh to Delhi, but today we are seeing our message of peace failing because of the incidents of violence and arson," Wangchuk said.

He also appealed to the administration to stop firing teargas shells and urged the government to be more sensitive.

"We are ending our fast immediately... the aim of the hunger strike is not fulfilled if our youth lose their lives."

"It is time to carry forward the dialogue with a cool mind. We will keep our agitation non-violent and I also want to ask the government to listen to our message of peace... when the message of peace is ignored, such a situation arises," he said

The situation is the outcome of frustration among the youth because they have been kept away from jobs, Wangchuk said, adding that there is "no democracy in Ladakh and the Sixth

Schedule promise made to the public has not been fulfilled either". The Constitution's Sixth Schedule, meant for the tribal population of the four northeast states of Tripura, Meghalaya, Mizoram and Assam, makes special provisions in terms of governance, powers of the president and the governor, type of local bodies, alternate judicial mechanisms and financial powers exercised through

A fresh round of talks was scheduled between the Ministry of Home Affairs and Ladakh representatives, comprising members of the LAB and the Kargil Democratic Alliance (KDA), on October

The two bodies have been jointly spearheading an agitation over the past four years in support of their demands and have held several rounds of talks with the government in the past.

Tension had been building up since Tuesday evening. Responding to the protest call, Leh town shut down today, and

took out a march through the streets of the town, chanting slogans in support of the Sixth Schedule and statehood, officials said.

He reaffirmed that the Administration stands dedicated to preserving the interests of Ladakh while ensuring development, progress, and security for all.

and Kargil Democratic Alliance. Series of meetings were held with them through formal channel of High Powered Committee as well as sub-committee and multiple informal meetings with leaders," the statement said.

They also put these offices on fire, attacked the security personnel, and torched the police vehicle," the statement said

The "unruly mob" attacked the police personnel in which more than "30 police/CRPF personnel were injured", it said. The home ministry said the mob continued to destroy public

property and attack the police personnel, and in self-defence. the police had to resort to firing in which, unfortunately, some casual-

"It is clear that the mob was guided by Sonam Wangchuk through his provocative statements. Incidentally, amidst these developments, he called of his hunger strike," it said.
