# Rains pound Jammu...

scheduled for September 3. Jammu University also suspended classes on Wednesday. meanwhile, 4th bridge over Tawi river was closed. "In view of heavy rains and considering safety of the people, 4th Bridge as well as the rotary have been closed for traffic. People are requested not to travel from Hotel Asia, Satwari Chowk and Bhagwati Nagar towards Major Somnath Chowk, 4th bridge. Further, road from Atal Chowk (Panjthirthi) towards Sidhra Bridge has also been closed due to landslide/shooting stones, posts Div Com Jammu on X.

At 8 pm, the water level in the Tawi river in Jammu city was recorded at 13.5 feet, just 0.5 feet below the alert level and 3.5 feet below the danger mark, officials said.

They said the Chenab is also flowing at 30.5 feet, a couple of feet below alert level. The Tarnah, Ujh and Ravi rivers in Kathua, and the Tawi in Udhampur crossed the alert levels during the day but started receding in the evening following a break in the rains.

The Basantar river in Samba also crossed the alert level of four meters during the day and s still increasing, the officials said.

In a fresh weather forecast at 8.50 pm, the weather department predicted a spell of heavy to very heavy rain at many places in Jammu, Kathua, Reasi, Doda, Udhampur, Rajouri and Ramban districts during the next 14-16 hours.

It also predicted moderate to heavy rain or brief intense showers at many places of the Pin Panjal range and south Kashmir. Heavy rain is also likely in Kishtwar, Poonch, Anantnag Shopian and Kulgam during the next 14-16 hours.

Cloudbursts, flash floods, landslides and waterlogging are also likely at a few vulnerable

Jammu recorded a maximum of 23.4 degrees Celsius -- 10 notches below the season's average -- while the night temperature was 21.5 degrees Celsius - 2.9 notches below the average. Batote in Ramban recorded the highest rainfall of 55.1 mm from 8.30 am to 5.30 pm, folowed by Bhaderwah in Doda, 42.6 mm, Katra, 32.7 mm and Jammu, 11.4 mm.

# Traffic suspended on...

Monday evening, a spokesman of the meteorological department predicted moderate to heavy rainfall in most parts of Jammu division on September 2 and 3.

"There is a possibility of heavy to very heavy rainfall over Kathua, Jammu, Udhampur and Reasi and moderate to heavy rainfall over Doda, Samba, Rajouri, Poonch, Ramban, Kishtwar in Jammu region and Anantnag and Kulgam in south Kashmir mainly towards late night of September 2 or early morning of September 3 till late afternoon," the spokesman said.

There is a possibility of cloudbursts, flash floods, landslides or shooting of stones from nillocks at many vulnerable places and rise in water level in rivers and streams, he said, askng people to stay away from water bodies and avoid landslide-prone areas.

The highway was opened for partial traffic only on Monday after remaining closed for six days and accordingly most of the stranded traffic, including trucks carrying essential commodities to Kashmir were cleared, the officials said.

The downpour was continuing in most parts of Jammu region when last reports were eceived, they said.

According to the MET department, Kathua district recorded the highest 25.2 mm of rainall in the past 24 hours ending 8.30 am Tuesday followed by Jammu (17.8 mm), Batote in Ramban (17.6 mm) and Katra (15.8 mm).

In Kashmir valley, Qazigund along Jammu-Srinagar national highway recorded overnight ainfall of 23.2 mm, Gulmarg in north Kashmir (14.8 mm), Pahalgam in south Kashmir (11.4 mm) and Srinagar (6.1 mm), the spokesman said.

However, the rains stopped before the start of the dawn and later the morning sun shone brightly in the valley.

### Police bust Pak...

The questioning of the duo led to the recovery of 411 grams of heroin and the arrest of drug rafficker Feroz Din alias Allu, a resident of the Rajbagh area of Kathua.

"He was in touch with a Pakistan-based drug smuggler," the SSP said. Further disclosure led

to the arrest of the kingpin and main financier from Tarn Taran, Punjab. "He was also in touch with the same Pak-based smuggler and was responsible for sending the proceeds of narcotics to Pakistan via the Hawala channel. Heroin and cash were recovered

from both drug traffickers and the kingpin," the SSP said. Saxena said the accused are hardcore criminals and have already supplied more than 30 kg

of heroin, which was dropped in Punjab and J-K to drug peddlers in adjoining districts. "They ran a sophisticated syndicate, taking all precautions, hence had been evading law enforcement till now. Further investigation in the case is ongoing, and more recovery and arrests are expected in the coming days," he said.

In the second case, police have arrested five drug peddlers from the same district and recovered heroin from them.

Murad Ali and Bagh Hussain were arrested with cash and heroin on Monday. Further inves tigation led to the arrest of three more accused, along with 20 grams of heroin and some cash, Saxena said. Highlighting the stringent action of local police, the officer requested residents to come forward and help police in curbing the menace.

# Narayana Hospital treats rare, critical cardiac condition in 16-year-old boy

KATRA: In a remarkable demonstration of medical expertise, teamwork, and compassionate care, Shri Mata Vaishno Devi Narayana Superspeciality Hospital (SMVDNSH), Katra, has successfully treated a 16-year-old boy suffering from a rare and life-threatening condition.

The patient was admitted in a critical state with dangerously low oxygen saturation (80%) and a rapid heartbeat of 180 bpm. Under the immediate care of Dr. Sanjeet Singh Chandail and Dr. Neha Rajput, Pediatricians, he was shifted to the ICU for emergency management. A 2D Echo revealed severely impaired heart function with an ejection fraction of just 25%. The boy required intensive monitoring and was placed on ventilator



upport for five days Over the next 12 days, a dedicated team comprising Dr. Sanjeet Singh Chandail (Pediatrician), Dr. Neha Rajput (Pediatrician), Dr. Mukesh Kumar Sharma (Cardiologist), and the hospital's critical care specialists worked round the clock to stabilize and treat him. The case was managed on the line of rare rickettsial myocarditis, a serious infection of the heart muscle seldom reported in pediatric patients and usually associated with very high mortality. According to Dr.

Singh Chandail (Consultant - Peadiatrics Department), this was one of the rarest and most severe pediatric cardiac cases successfully managed at the hospital, and the outunderscores comeexceptional skill, coordination, and perseverance of the medical team.

The entire treatment was provided free of cost under the Ayushman Bharat Health Card, ensuring the family did not face any financial burden during this life-threatening emergency.

# Court discharges accused in abduction and assault case

JAMMU: Presiding Officer Fast Track Court, Jammu. Amarjeet Singh has discharged Abhishek Bajaj in case of alleged abduction, confinement and assault, holding that no prima facie case was made out to proceed with trial. The case stemmed from FIR No. 43/2021 registered at Police Station Nowabad against Abhishek Bajaj of Rajinder Nagar, Jammu, for offences under Sections 376, 511, 344, 427, 385, 201, 504 and 506 of IPC. According to the prosecution, the complainant, a faculty member at a private institute, went missing on January 17, 2021, and was later traced in Bangalore after 48 days. She alleged that the accused threatened her family, compelled her to leave with him. usurped her money and assaulted her. The defence, represented by advocate Deepak Sharma, argued that the prosecutrix travelled voluntarily with the accused from Jammu to Delhi, Goa and then Bangalore, and that medical evidence showed no injuries. It was also submitted that her statements were contradictory and no independent witnesses supported the confinement claim. Presiding Officer Amarjeet Singh Langeh noted that the prosecutrix's conduct, lack of corroborative evidence and contradictions weakened the case. The court observed that "continuing the trial would only be a futile exercise," and therefore discharged the accused, dismissing the challan.

# Tribunal raps JU for "Illegal" move to replace contractual staff with contractual

JAMMU: In a major setback to the University of Jammu, the Central Administrative Tribunal (CAT) Jammu Bench has quashed the University's advertisement inviting fresh applications to replace existing contractual faculty with another set of contractual appointees, terming the move illegal and arbi-

The order was passed by a Bench comprising Judicial Member Rajinder Singh Dogra Administrative Member Ram Mohan Johri, while deciding five connected cases filed by lecturers working on academic arrangement basis in different campuses of the

University.

The petitioners-Dr. Harpreet Kaur (Punjabi), Dr. Kuldeep Raj Sharma (Chemistry), Gaurav Sharma (Management), Naveen Kumar (Geography, Bhaderwah Campus) and Dr. Som Raj (Economics, Udhampur Campus)approached the Tribunal against Advertisement Notification dated April 1, 2025 which sought fresh contractual engagements for the 2025-26 session.

The applicants submitted that they had been appointed after due selection processes since 2019, their contracts extended session after session, and could not be thrown out midway to be substituted by another batch of contractual staff.

After hearing both sides, the Tribunal relied on Supreme Court and High Court judgments including Rattan Lal vs State of Harvana, Piara Singh, Manish Gupta, and Mushtaq Ahmed, which clearly laid that one  $\operatorname{set}$ down contractual/temporary employees cannot be replaced by another set of contractual/temporary employees, and can only be replaced by regularly appointed candidates through proper recruitment.

Rejecting the University's contention that some applicants had appeared in the fresh selection process, the Tribunal held that participation does not prevent candi-

dates from challenging the illegality of the process.

The Bench ordered that the April 1 notification "is quashed to the extent it permits replacement of existing contractual faculty by another set of contractuals." It directed that the petitioners shall continue on their posts till regular recruitment is made. The University was also instructed to complete regular recruitment within six months. The ruling brings major relief to contractual lecturers, some of whom have been serving for over five years, and is expected to have wider implications for academic arrangements across the Union

# Tribunal relief to designer forced to work in 3 districts a week

The Central JAMMU: Administrative Tribunal (CAT) Srinagar Bench has granted major relief to a Handicrafts Department employee by staying an order that required her to perform duties in three districts every week, calling the arrangement prima facie harsh and unsustainable

The ruling came in petition filed by Shaheena Bhat, a Designer in the J&K Handicrafts Non-Gazetted Service, who challenged Order No. 181 DHHK of 2025 dated April 30, 2025, issued by the Director, Handicrafts and Handloom, Kashmir.

Adv N.A. Beigh appearing for the petitioner argued that she was appointed as Designer through JKSSRB in 2009 and has since been working at the School of Designs, Kashmir Haat, Srinagar. The impugned order directed her to attend

at Srinagar on Monday-Tuesday, Budgam Wednesday-Thursday, and Ganderbal on Friday-Saturday, effectively requiring her to function in three districts within a single week. The petitioner maintained

that the order was punitive, mala fide and in violation of G.O. 861-GAD of 2010 and G.O. 948-JK(GAD) of 2020, which govern transfer policies. She further contended that her statutory role as Designer is to create new designs, not to replace Craft Instructors, and that such an arrangement disrupted both her professional duties and personal life.

Defending the decision, DyAG Syed Musaib submitted that the order was aimed at reviving the dying art of handicrafts by involving Designers in training programmes across districts.

The Bench comprising Member (J) M.S. Latif and

Member (A) Prasant Kumar observed that while the administration has powers to transfer employees in exigency, requiring one official to attend duties across three districts in a week is "unknown to jurisprudence" and "derogatory to the human rights of an employee"

The Tribunal also noted that the order was openended ("till further orders"), which could not be justified without a defined tenure for training.

The CAT directed that, till the next hearing on September 22, 2025, the petitioner shall be allowed to continue at her present posting in the School of Designs. Srinagar. The Tribunal also permitted her to move a representation before the competent authority for modification of the order, while clarifying that the interim relief applies only to the petitioner.

# HC quashes preventive detention of Kathua resident

JAMMU: The High Court of Jammu & Kashmir and Ladakh has quashed the preventive detention of a Kathua resident. holding that the detention order suffered from serious legal

Justice M.A. Chowdhary, while delivering judgment in HCP No. 62/2025, set aside Detention Order No. PSA/146 dated February 13, 2025, issued by the District Magistrate, Kathua, against Shamas Din, 35, of Gali Sadrota village in Billawar tehsil. The petitioner, represented by advocates S.H. Ashrafi, Satish K. Sharma and Sahil Singh, argued that the detention was based on vague Daily Diary Reports (DDRs) and preventive proceedings under Section 128 of BNSS, 2023, none of which culminated in an FIR. They further contended that the grounds of detention were a verbatim reproduction of the police dossier and that the detenue was never informed of his right to make a representation before the detaining authority.

The Government, represented by GA Suneel Malhotra, defended the order, claiming that the detenue had links with banned organisations and was functioning as an Over Ground Worker (OGW) for terrorists.

After examining the record, the Court observed that the grounds of detention lacked independent application of mind, and the omission to inform the detenue of his right to represent before the detaining authority vitiated the order. The Court also noted that DDR entries, without registration of an FIR, could not form the basis of such a serious preventive action. "The impugned order has been passed in breach of constitutional and statutory safeguards and is unsustainable in law," the Court said while ordering the immediate release of the detenue, if not required in any other case.

# Court acquits husband in wife's death case

JAMMU: The Principal Sessions Judge, Anantnag Tahir Khurshid Raina, has acquitted Bilal Ahmad Sofi of Kanelwan Bijbehara, who had been facing trial for the alleged murder of his wife in 2017, giving him the benefit of doubt after holding that the prosecution failed to establish charges beyond reasonable doubt. The case arising from FIR No. 20/2017 registered at Police Station Anantnag under Section 302 RPC following a complaint by the victim's father, Gh. Mohammad Bhat, alleging that Sofi had beaten and assaulted his daughter Sumi Jan-who was three months pregnant-leading to her death at SKIMS, Soura

The prosecution relied on witness statements claiming that the accused had suspected his wife's character and attacked her at her parental home, plucking her hair and kicking her abdomen, after which she succumbed to injuries

During the trial, the prosecution examined 18 witnesses, including family members who alleged that Sofi beat the deceased and prevented her immediate medical treatment. Medical witnesses confirmed that the deceased was pregnant, but post-mortem doctors did not find external injuries consistent with homicidal assault, except hair found plucked from her scalp. Sofi, represented by senior advocate M.D. Shawl, denied the charges

and claimed innocence, arguing that contradictions in witness testimonies and lack of medical corroboration demolished the prosecution's case.

Principal Sessions Judge Anatnag Tahir Khurshid Raina noted several inconsistencies, including contradictory statements by key witnesses, absence of injuries on vital parts of the deceased's body, and failure of the prosecution to conclusively link the accused to homicidal assault.

The Court also observed that circumstantial evidence such as recovery of hair and allegations of suspicion over character were insufficient to sustain a conviction without clear medical or ocular proof.
