Subject: Ensuring Student Safety While Reopening Schools Post-Floods –reg.

In light of the recent heavy rains and floods that have severely impacted various parts of the region, it has come to our attention that several school buildings have sustained structural damage, rendering them unsafe for occupancy.

The safety of our students, teachers, and staff must remain the highest priority. It is essential that no school building be reopened without a thorough structural assessment by competent authorities. Buildings that have been submerged or have shown signs of damage must remain closed until they are certified as safe.

Therefore, you are hereby directed to implement the following measures with immediate effect:

1. Coordinate with local administration, village leaders, and community-based organizations to facilitate temporary arrangements and ensure that basic amenities like drinking water, sanitation, and seating are available in these alternative spaces.

2. In areas where school buildings have been declared unsafe or are undergoing repairs, you are directed to explore community-based alternatives to ensure that education is not disrupted. This includes utilizing available infrastructures such as community halls, panchayat ghars, religious places (e.g., temples, mosques, churches, and gurdwaras) – on a voluntary basis.

3. It must also be ensured that all school principals, teachers, and staff are duly informed of these directives and are vigilant in adhering to the safety protocols to protect students.

4. HOIs shall inspect buildings before start of physical classes and shall start classes only after being satisfied about the safety of schools and readiness of school for start of physical classes.

It is again reiterated that all school principals, teachers, and staff must be duly informed of these directives and must remain vigilant in adhering to the prescribed safety protocols to ensure the protection and well-being of students.

HC stays FIR against two Punjab labourers alleging custodial torture at Atal Setu

JAMMU: The High Court of J&K and Ladakh at Jammu on Tuesday stayed FIR No.0061/2025 registered at Police Station Basohli against two Punjab labourers who alleged brutal custodial torture at Atal Setu.

Justice Vinod Chatterji Koul, after hearing Advocate S.S. Ahmed for the petitioners, issued notices to Principal Secretary Home, DGP J&K, IGP

Jammu, SSP Kathua and SHO Basohli, returnable in four weeks.

Petitioners Sukar Deen and Farid Mohammad, residents of Pathankot, sought quashment of the FIR and compensation of Rs 50 lakh each for alleged midnight torture by Basohli police led by the SDPO. Their counsel submitted that to cover up custodial excesses, a false FIR was lodged accusing the labourers of attacking police.

Referring to the Munsiff/JMIC Basohli's order dated June 30, 2025, Advocate Ahmed pointed out that the Magistrate declined police remand after observing violation of D.K. Basu guidelines and recording that both accused were medically unfit with visible injuries.

The High Court, after perusal of submissions, stayed operation of the FIR till further orders and listed the matter for October 18, 2025.
