



# Congress urges comprehensive relief and rehabilitation measures amid Jammu flood crisis

JAMMU: In view of the ongoing devastation caused by incessant rains and flash floods in Jammu province, the District Congress Committee (DCC) Jammu Urban convened an emergency meeting at Congress Headquarters to review the situation and chart relief measures for affected communities. The meeting was convened by President DCC Jammu Urban, Manmohan Singh, and chaired by PCC Working President, Raman Bhalla, Senior leaders including Yogesh Sawhney, Rajnish Sharma, Sanjeev Panda, Pawan Dev Singh, Anuradha Sharma, Satpal Sapolia, Rakesh Sharma, Vijay Kumar, and several

others attended the meeting. Leaders expressed grave concern over the widespread impact of the unprecedented rainfall, which has disrupted vehicular traffic due to massive landslides, severely affected normal life, and caused significant damage to both public and private property.

The Congress delegation criticized the central government for failing to announce a comprehensive relief package, even after the visit of Home Minister Amit Shah to the worst-affected areas. The leaders also condemned the authorities for not taking advance measures regarding the yatra, despite clear weather warnings and government advisories. They highlighted the

urgent need for a high-level probe by a sitting or retired High Court judge to ensure a free, fair, and independent inquiry into administrative lapses. Addressing the gathering, Raman Bhalla lauded the appeal of Leader of Opposition Rahul Gandhi for a mega relief package and described the announced Rs. 209 crore package as grossly inadequate, terming it insufficient to cover the massive losses. Bhalla urged the administration to provide packaged cooked food to uprooted families and free ration for six months to the affected population. He also criticized the shortage of chlorine for safe drinking water and delayed availability of essential supplies.
