How a "Coma" saved a little girl's life at AIIMS Jammu

JAMMU: The Department of Neurosurgery at AHMS Jammu recently demonstrated the cutting-edge capability and interdisciplinary coordination that is transforming paediatric head trauma care in the region.

Last week, an 8-year-old girl presented to the hospital with a severe traumatic brain injury, after a fall from the first floor, in an unconscious state with a low Glasgow Coma Scale (GCS) score of 7, indicating a critical and life-threatening

Surgery in young children for head injuries is often associated with significant risks and complications.

Recognizing this difficulty, the neurosurgery team, led by Dr Shaurya Darbari and Dr Kanav Gupta, decided to take a measured and innovative approach to her treatment. They inserted an intracranial pressure (ICP) catheter directly into the child's brain to continuously monitor the pressure inside the skull. Medical teams can detect dangerous swelling with this invasive device and take action before irreparable harm is done.

In close collaboration with the anaes-

thesia team, including Dr. Slomi Gupta and Dr. Kanika Gupta, and the pediatrics team led by Dr. Samriti Gupta, Dr. Sheetal Ganju, Dr. Radhika Uppal, Dr Harkirat, and Dr. Vivek Pandita, the child was placed in a carefully controlled therapeutic coma. Unlike a natural coma, this medically induced coma shuts down brain activity temporarily, allowing the brain to rest and heal.

Guided by the ICP catheter readings, the child remained in this induced coma for five days, during which her intracranial pressure was closely monitored to maintain it at safe levels without the need for repeated CT scans. Once the ICP readings stabilized and the swelling decreased, the child was gradually brought out of the coma and extubated. Today, she is neurologically intact-eating, talking with her parents, playing, and preparing to return to school. She was discharged from the hospital recently, marking a full-circle recovery from a condition that could have otherwise resulted in devastating outcomes.

"The role of ICP monitoring is invaluable in managing severe brain injuries, though these devices are usually costprohibitive and inaccessible in many

We have all modes of treatment for head injuries available here-from conservative management to the most complex neurosurgical procedures. In this particular case, while we opted for the rapeutic coma and ICP monitoring, our operation theatre was kept ready round-the-clock for five days in case the child needed emergency surgery. This comprehensive preparedness ensures that we can respond immediately to any change in a patient's condition," said Dr. Shaurya Darbari, Assistant Professor and Head of Neurosurgery.

Prof. (Dr.) Shakti Kumar Gupta, Executive Director and CEO of AHMS Jammu, added, "Our institute is committed to providing emergency neurosurgical and trauma services locally, which is crucial for preserving the 'golden hour'-the critical time window where immediate intervention can save lives and improve outcomes. Before AIIMS Jammu's neurosurgical services began, patients often had to travel long distances to other cities, losing valuable

Dr. Jitendra announces additional weather equipment for J&K

NEW DELHI/JAMMU: Union Minister Dr. Jitendra Singh convened a high-level meeting with the Divisional Commissioner Jammu and Deputy Commissioners of Doda, Kishtwar, Ramban, Kathua, and Udhampur via video conferencing to assess the ongoing relief and rehabilitation measures in Jammu & Kashmir following unprecedented rainfall, flash floods. and cloudbursts.

Dr. Singh announced that under the Government of India's "Mission Mausam." four additional weather radars will be installed in J\&K to enhance district-wise weather forecasting accuracy. Currently, three radars are already operational. The Minister directed the Ministry of Earth Sciences and the Meteorological Department (IMD) to main-



tain round-the-clock weather monitoring and provide timely alerts to minimize losses.

Accompanied by Secretary, Ministry of Earth Sciences Dr. M. Ravichandran and IMD Director General Dr. M. Mohapatra, Dr. Singh stressed the importance of district-specific forecasts for North Indian states including J&K, Himachal Pradesh, Uttarakhand, and Punjab.

The Minister, also MP from Udhampur, praised the tireless efforts of district administrations in rescue operations, ration and medicine

supply, and ensuring temporary shelter for affected families. He assured that two more consignments of ration kits and advanced water filters would reach the region by tomorrow. These are being dispatched from his own MP funds in addition to government support.

Dr. Singh informed that Prime Minister Narendra Modi is closely monitoring the situation and has directed immediate relief action. Home Minister Amit Shah has formed an Inter-Ministerial Committee to assess damage and coordinate central assistance; the team is scheduled to visit Kathua today.

Divisional Commissioner Ramesh Kumar presented a comprehensive damage report. DCs of all five districts shared updates on relief operations. DC Udhampur, Saloni

Rai, reported 38 relief camps housing over 2,000 people, while DC Kathua, Rajesh Sharma, reported 26 camps 1,900 evacuees. with Restoration of damaged roads and water schemes is under-

DC Ramban, Alyas Khan, detailed the aftermath of a cloudburst in Drubla, Rajgarh, which claimed four lives. Nearly 950 people were evacuated. DC Kishtwar, Pankaj Kumar Sharma, highlighted the successful rescue of five workers trapped in a landslide at the Rattle Power Project site.

Dr. Jitendra commended civil society members and local bikers for acting as first responders, exemplifying a "whole-of-society" approach. He assured full central and state support, emphasizing that no effort will be spared in aiding affected communities.
