The event will be supported by a professional event management agency, responsible for logistics, branding, athlete facilities, and post-event management.

The marathon will also be featuring a Marathon Expo and a Gala Cultural evening, aimed at engaging athletes, tourists, and locals, while showcasing Kashmiri art, culture, and traditions

Importantly, the event is being aligned with eco-friendly practices. The marathon will encourage youth involvement through school-level activities and fun runs, while NGOs and local volunteers will be engaged as "eco-volunteers" for route clean-ups and sustainability initiatives.

On the occasion, the Chief Minister launched the promotional video of Kashmir Marathon-2025 and was presented with his participation certificate from last year's edition, in which he himself successfully completed the half marathon.

Reiterating his government's commitment, Omar Abdullah said the Kashmir Marathon will be positioned as a world-class sporting spectacle that celebrates the Valley's scenic beauty, promotes tourism, and fosters a spirit of health, wellness, and community togetherness.

to Sangaldan railway station in Ramban, aimed at ferrying hundreds of people stranded in Jammu and Ramban belts due to the highway closure, besides facilitating students, and employees between these areas.

The train track distance between Katra and Sangaldan is 63 km and commuters will be charged only Rs 20.

The two local passenger trains will connect twin stations via Reasi, Bakkal, and Dugga stations, and back, from September 8 to September 12, a railway official said. "On the request of the administration, the Railways Board decided to run the train service for five days to facilitate stranded passengers, patients with health issues, and others in the area. So the first train left Katra for Sangaldan at 8:40 am," a senior railway official said

He said on the first day, 464 passengers departed from Shri Mata Vaishno Devi station for Sangaldan railway station, where where train will return at 2 PM.

With roads blocked due to landslides, this five-coach train offers a much-needed lifene for locals and nilgrims. A large number of passengers have been stranded in Re-Jammu, Ramban, Doda, and Kishtwar districts due to the closure of highways and

"We thank the railways and administration for running the trains to facilitate our fourney home. We were stranded in Jammu for nine days. The highway was closed. Today, we are happy to leave for home in Sangaldan," Rafi Mohammad, a local travelling by the train, said.

Similarly, Zeenat Begum, who was stranded after her surgery in Jammu for over one week, is happy to return home to Banihal. "We are very happy. We thank the railways. It is a great relief for us," she said.

Union Minister Dr Jitendra Singh appreciated the move by the railways, and said on X, "In the absence of road connectivity beyond Udhampur, arrangements have been made to carry essentials via the newly introduced Special Local Passenger Train from Katra to Ramban Sangaldan.

He added that these essentials can thereafter be transported by road to the Doda

Singh said the weather seems clear, and highway authorities are working round-theclock to clear the national highway blockade at Thard and Bali Nallah. "Hopefully by ate evening, it may be possible to allow traffic movement." he said.

Normal train traffic has been disrupted in Jammu and Kashmir since August 26 after heavy rains and flash floods in the Union Territory. So far, Northern Railway has announced the restoration of 21 trains.

His party has failed to take action against him, the BJP leader said, adding it appears that his party, including its convenor and former chief minister Arvind Kejriwal, support his activities.

"It is high time to deal with all such elements in accordance with the law so that pubic confidence is upheld in the administration," he said.

Meanwhile, in an official communiqué, the Jammu and Kashmir Assembly Secretariat informed that "It has been highlighted/reported in some media reports, social media Platforms, X (formerly Twitter) that the Jammu & Kashmir Legislative Assembly Secretariat has endorsed the slapping of provisions of Public Safety Act 1978 on Mehraj Malik, MLA (52-Doda Assembly Constituency) which is factually

incorrect and baseless as the Secretariat has no role in it."

It further reads that, "However, this Secretariat was under an obligation in terms of Rule 260 of Rules of Procedure and Conduct of Business in Jammu and Kashmir Legislative Assembly to inform all the Members of Jammu and Kashmir Legislative Assembly about the aforesaid Arrest/detention of the Member.'

Meanwhile, today late evening Mehraj Malik was shifted to Kathua jail.

Chief Minister Omar Abdullah has expressed his displeasure over Public Safety Act (PSA) slapped on MLA Doda Mehraj Malik, saying there was no justification for detaining him.

He said Malik was not a threat to "public safety", and using this "discredited" law to detain him was wrong. Taking to micro-blogging site X, Chief Minister Omar Abdullah said: "There is no justification for detaining Mehraj Malik under PSA. He's not a threat to "public safety" & using this discredited law to detain him is wrong." "If the unelected government can use its powers against an elected representative like this then how does anyone expect the people of J&K to continue to have faith in democracy," he added on X.

Surjeet Singh, Parbhari BJP Minority Morcha (BJPMM) District Jammu, has strongly condemned the objectionable language used by MLA Doda Mehraj Malik against Deputy Commissioner Doda, Harvinder Singh.

In a statement issued here today, Surjeet Singh said that the words used by the MLA were cheap and highly condemnable, and such behaviour is unacceptable from a public representative.

He asserted that leaders are expected to maintain dignity and respect in public life, and such incidents not only tarnish the image of the institution of democracy but also hurt the sentiments of civil society

"Every responsible and cultured citizen of society strongly condemns this incident. We demand strict action against the MLA so that such behaviour is not repeated in future. A public representative should be an example of discipline and humility, not of arrogance and disrespect," Singh remarked.

## IMCT visits Anantnag...

In Anantnag, Deputy Commissioner, presented a detailed briefing to the team covering the extent of damages, relief measures undertaken like evacuation of vulnerable families, provision of temporary shelters, restoration of connectivity, and health and sanitation interventions as well as the requirements for long-term rehabilitation.

During the meeting, a comprehensive plan for flood mitigation and resilience-building was also discussed to strengthen long-term disaster preparedness in the district.

The IMCT, along with district officials, thereafter conducted a spot visit to various affected areas to assess damages on the ground, including river embankments, roads, nallahs, and public infrastructure, besides reviewing immediate restoration priorities.

The IMCT, during the visit, highlighted that the Union Government is closely monitoring the situation at the highest levels and will extend full financial and logistical support for relief, rehabilitation, and long-term mitigation measures in Anantnag dis-

The IMCT also held a review meeting to assess the damages caused by recent floods and incessant rainfall across district Shopian as well as relief and rehabilitation measures carried out by district administration.

Deputy Commissioner, Shopian, Shishir Gupta, presented a detailed assessment of damages suffered in Shopian district before the IMCT members which included senior officers from NDMA, Ministry of Rural Development, Ministry of Jal Shakti, MoRTH, Agriculture & Farmers Welfare, Ministry of Power and Finance.

During the meeting, DC Shopian gave a detailed PowerPoint presentation covering the disaster preparedness framework. He informed the team that Shopian, spread over seven tehsils, although comparatively less vulnerable to floods than other districts,

has suffered damages to public infrastructure including Roads, Bridges, Water Supply Schemes, Power assets and standing crops and houses of lower riparian villages in Zainapora sub division

DC Shopian also briefed on immediate restoration of services which were disrupted during floods and relief and rescue measures carried out in the district.

DC Shopian informed the IMCT that in Shopian district, 2 out of 6 major 33 KV lines,16 feeders,13 transformers and 19 electric poles were affected and have been restored; 55 out of 92 drinking water supply schemes were impacted and all have been restored, 25 roads were damaged of which 24 stand restored and 1 is under restora tion besides PMGSY road length of about 860 metres was damaged.

The DC also apprised the IMCT that Mughal Road at KM 24 witnessed severe dam age due to sliding and efforts are on to keep it open 24\*7.

It was further informed that 28 villages in low lying areas covering 4284 hectares with a population of 17,200 were impacted, 4 villages namely Hydergund, Zainapora Melahura/Wandina and Reshipora were directly hit, 21 shelter sheds were established 129 families evacuated and 644 persons rescued.

The DC also briefed that 11 residential houses have been damaged while crop and orchard losses are being assessed. The DC informed the team that Shopian administration has already initiated both

short-term restoration measures and long-term resilience planning. He added that protective and restoration works like crate bunds, embankments and flood protection measures have been initiated at Hydergund, Zainapora, Safanagri and other vulnera

At Kulgam, the team took stock of relief, rehabilitation and restoration measures in the aftermath of recent floods in the district.

The team took detailed assessment and review of damages caused by recent floods cloudbursts, and landslides in the district.

The meeting was attended by the Deputy Commissioner Kulgam, Athar Aamir Khan; Senior officers of district administration and engineers from key departments like PWD (R&B), Jal Shakti, Irrigation & Flood Control, KPDCL, PMGSY, and sen ior officers of Health, Agriculture, Horticulture, Animal & Sheep Husbandry, FSC and Revenue departments
